In pursuance to the Ministry of Personnel, Public Grievances & Pensions, Govt. of India's OM No 42/12/2009-P & PW(G) dated 23<sup>rd</sup> September, 2009 on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to decide that the Dearness Relief (DR) payable to the State Government Pensioners/Family Pensioners shall be enhanced from the existing rate of 22% to 27% with effect from 01-07-2009.
