In continuation of this office Circular No.Pen-3/3-11/Assam/IR/08-09/6386 dated 26-09-2008 on the subject cited above I am to state that the Govt. of Assam has sanctioned another two instalments of Interim Relief @ 15% each (raising total IR to 40%) to its pensioners/family pensioners/extra ordinary pension holders w.e.f. 01-01-2009 vide Finance (Pay Research Unit) Department's O.M.No.FPC.6/2008/pt./4 dated 02-01-2009 and O.M.No.FPC.6/2008/30 dated 04-09-2009.

You are, therefore, requested to make necessary arrangement for payment of 30% Interim Relief w.e.f. 01-01-2009 in addition to 10% IR already sanctioned and authorised to the Assam Govt. pensioners/family pensioners/extra ordinary pension holders subject to adjustment of any such payment, if made earlier.



OFFICE MEMORANDUM

**Sub:- GRANT OF INTERIM RELIEF TO THE STATE GOVERNMENT  
EMPLOYEES/PENSIONERS.**

In continuation of this Department's O.M.No.FPC.6/2008/13 dtd. 30-5-2008, the Governor of Assam is pleased to sanction until further orders an additional Interim Relief at the rate 15% (fifteen percent) of Basic Pay/Basic Pension to all eligible State Government employees/Pensioners drawing State pay scale/Pension with effect from 1-1-2009 on the following conditions :-

- i) The total rate of Interim Relief with effect from 1-1-09 will be admissible @ 25%, without any minimum or maximum limits. This will be inclusive of the Interim Relief @ 10% with effect from 1-4-2008 sanctioned earlier vide O.M.No.FPC.6/2008/13 dtd.30-05-2008.
  - ii) The Interim Relief, now sanctioned, will not form a part of pay/pension for the purpose of determining pay and allowances calculated on the basis of pay or emoluments.
  - iii) The Dearness Pay/Dearness Pension sanctioned vide O.M.No. FPC.12/2004/72 dtd.20-12-2005 merging/converting 50% Dearness Allowance/Dearness Relief into Dearness Pay/Dearness Pension shall not be taken into account for the purpose of calculation of the above Interim Relief.
  - iv) The order will also apply to the members of the Work Charged establishment holding posts carrying identical pay scale as admissible to the members of corresponding categories of regular Government establishment.
  - v) The above Interim Relief will be paid alongwith the pay bill of January, 2009.
  - vi) The above Interim Relief will be subject to adjustment against the arrears arising out of future revision of pay.
2. The expenditure on account of Interim Relief will be debited to the Service Head from which the pay and allowances of the employees/pensioners are met.
  3. Fraction of 50(fifty) paise and above shall be rounded off to next rupee.


