OFFICE MEMORANDUM

Subject:- Grant of Dearness Allowance to the employees of the State Government w.e.f.1.7.2009 in the revised pay structure.

In continuation of this Department Office Memorandum of even number dated 26th August, 2009, the Governor, Himachal Pradesh is pleased to enhance Dearness Allowance from the existing rate of 22% to 27% on the Revised Basic Pay (including applicable Grade Pay) w.e.f. 1 .7. 2009 in respect of employees of the State Government.

2. The additional Dearness Allowance of 5% (five percent) shall be paid in cash w.e.f. 1.9.2009 with the salary of September, 2009 to be paid in October, 2009 and the arrears accrued from 1.7.2009 to 31.8.2009 shall also be paid in cash.

3. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.


4. Other terms & conditions as contained in the O.M. of even No. dated 26th August, 2009 will remain the same.

5. These orders will be applicable to all those working in various Government Departments. As far as the PSUs/ Universities/ Autonomous Bodies/ Boards etc. are concerned, the managements of these PSUs/ Universities/ Autonomous Bodies/ Boards etc. would take an appropriate decision in this regard, considering the availability of resources in their organizations.


