Temporary Increase to the State Pensioners regarding 5th Pay Commission W.E.F. dt. 01.07.2008 & dt. 01.01.2009.

RESOLUTION:-

Vide Government Resolution dated 15/04/2008 cited in the preamble, Government has granted Temporary Increase as the rate of 47 % to the State/Panchayat Pensioners/Family Pensioners. As per the recommendation of Sixth Pay Commission State/Panchayat Pensioners/Family Pensioners were granted Temporary Increase on revised Pension/Family Pension w.e.f. dated-01/01/2006 accordingly to Gujarat State Service (Revision of Pay) Rules-2009 from time to time.

Pensioners/Family Pensioners those were not granted benefit accordingly to Sixth Pay Commission and are getting Temporary Increase at the rate of 47 % at present. After careful consideration, Government is pleased to revised as follow :-

| Admissible From | Admissible Rate |
|--------------------------------------|-------------------------------------------------------------------------|
| Date: 1 st July, 2008. | Monthly Temporary increase 54 % (Fifty Four) of Pension/Family Pension. |
| Date: 1 st January, 2009. | Monthly Temporary increase 64 % (Sixty Four) of Pension/Family Pension. |

2. Temporary increase will be admissible on the amount of basic pension/family pension and 50 % merged dearness relief as per the order G.R. dated 13.10.09 on the preamble.
3. These orders shall be applicable to Parvashi Pensioners and Jivai Pensioners also.
4. Payment of Temporary Increase involved a fraction of 50 paisa or more shall be rounded off to the next higher rupee.
5. The arrears and monthly installment of Temporary Increase from the July-2008 and January 2009 will be paid in cash.
6. Other conditions and instruction regarding Temporary Increase to Pensioners/Family Pensioners contained in the Government Resolutions, Finance Department referred to above will remain unchanged.

7. All Accountant Generals outside Gujarat State are requested to take necessary action to authorize all the disbursing authorities under their control for making payment to Gujarat State Pensioners drawing pensions from their State Treasuries, including Public Sector Banks.

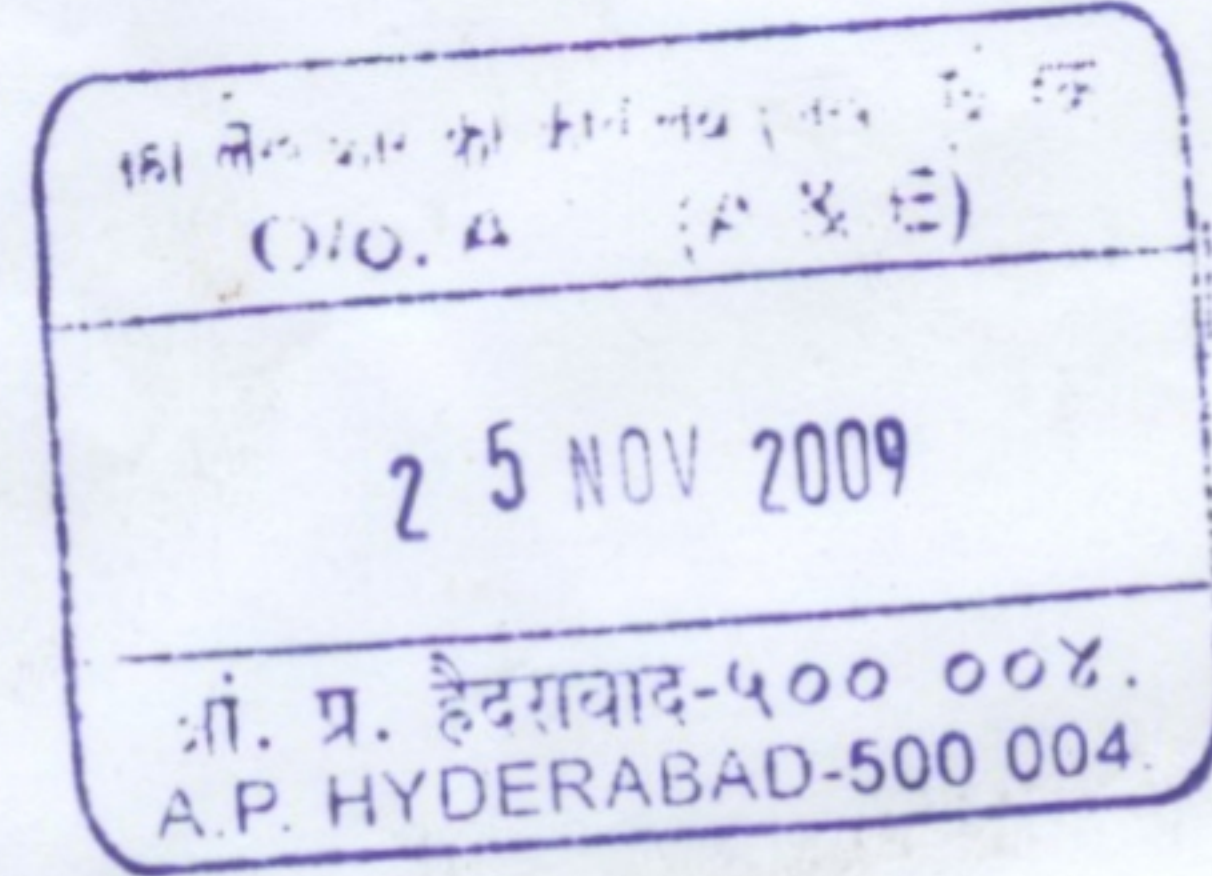


The Government has decided to pay 22% Temporary Increase (Dearness Relief) to State Government Pensioners / Family Pensioners vide GR, F D, No. HGV-1009-512-P Dated 22/05/2009. Government has now decided to increase the rates of Temporary Increase (Dearness Relief) admissible to State Government Pensioners/Family Pensioners with effect from 01-07-2009 as under:

| Admissible From | Admissible rate |
|---------------------------------|-----------------------|
| Date 1 st July, 2009 | 27 % of Basic Pension |

1. Payment of Temporary Increase (Dearness Relief) involving a fraction of a rupee shall be rounded off to the next higher rupee.
2. Temporary Increase (Dearness Relief) at the rates indicated in above table will also be admissible on the additional basic pension/additional family pension available to older Pensioners/Family Pensioners based on their age as indicated in Government Resolution, Finance Department, No. PGR-1009-4-Pay Cell (M), dated 13th April 2009 and Government Resolution, Finance Department, No. PGR-1009-5-Pay Cell (M), dated 13th April 2009.
3. The amount of revised Temporary Increase with effect from dated : 01-07-2009 to the state Govt. Pensioners / Family Pensioners will be paid in cash.
4. It will be the responsibility of the Pension Disbursing Authority to calculate the quantum of Dearness Relief payable in each individual case.
5. All Accountant Generals of the respective States/Central Administrative Authority except Gujarat State are requested to take necessary action to authorize all the disbursing authorities under their control for making payment to Gujarat Pensioners drawing pensions from their State Treasuries, including Public Sector Banks.

6. Other provisions governing grant of temporary Increase (Dearness Relief) to pensioners such as regulations of dearness relief during employment / re-employment, regulations to temporary Increase (Dearness Relief), where more than one pension is drawn etc. will remain unchanged.
