Resolution:

The Government has now decided to include the deceased employees as well as the pensioners/family pensioners of the categories/class mentioned below under the Para No. (D)-c of Government Resolution, Finance Department, dated 20-3-2009 and the amount of arrears of Pay/ Pension/ Family Pension payable to them is to be paid in cash to their heirs in one installment instead of five yearly installments.

- (1) Employees, who have died on 1-4-2009 and thereafter.
- (2) Pensioners/ Family Pensioners who have died during the period from Dt.1- 1-2006 to 31-3-2009 (including both these days)
- (3) Pensioners/ Family Pensioners who have died on 1-4-2009 and thereafter.
