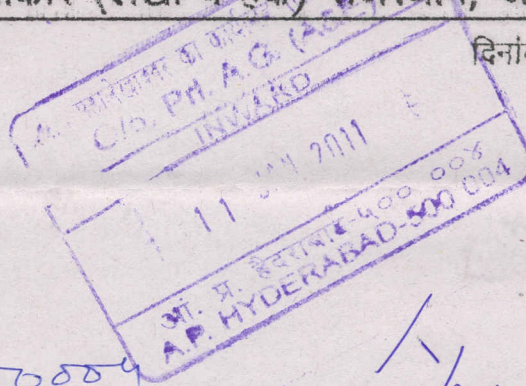

Notification

In exercise of the powers conferred by proviso to Article 309 of the Constitution of the India the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Judicial Officers (Medical Facilities) Rules, 2008, namely:-


1. Short title and commencement.- (1) These rules may be called the Rajasthan Judicial Officers (Medical Facilities) (Amendment) Rules, 2010.

(2) They shall be deemed to have come into force with effect from 01-01-2006.

2. Substitution of rule 8.- The existing rule 8 of the Rajasthan Judicial Officers (Medical Facilities) Rules, 2008 shall be substituted by the following, namely:-

"8. Additional medical allowance.- Serving Judicial Officer shall be entitled to receive rupees one thousand per month and Retired Judicial Officer shall be entitled to receive rupees one thousand five hundred per month as medical allowance in addition to the benefits of medical reimbursement."

भारत के संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए राजस्थान के राज्यपाल, राजस्थान न्यायिक अधिकारों (चिकित्सा सुविधा) नियम, 2008 को और संशोधित करने के लिए, इसके द्वारा निम्नलिखित नियम बनाते हैं, अर्थात्:-

1. संक्षिप्त नाम और आरंभ.— (1) इन नियमों का नाम राजस्थान न्यायिक अधिकारों (चिकित्सा सुविधा) (संशोधन) नियम, 2010 है।

(2) ये 01.01.2006 से प्रवृत्त हुए समझे जायेंगे।

2. नियम 8 का प्रतिस्थापन.— राजस्थान न्यायिक अधिकारों (चिकित्सा सुविधा) नियम, 2008 के विद्यमान नियम 8 के स्थान पर निम्नलिखित प्रतिस्थापित किया जायेगा, अर्थात् :-

“ 8. अतिरिक्त चिकित्सा भत्ता.— चिकित्सा प्रतिपूर्ति फायदों के अतिरिक्त चिकित्सा भत्ते के रूप में सेवारत न्यायिक अधिकारी एक हजार रुपये प्रति मास और सेवानिवृत्त न्यायिक अधिकारी एक हजार पांच सौ रुपये प्रति मास प्राप्त करने का हकदार होगा।”

Jaipur, dated : 25 JUN 2010

Sub.: Retirement benefits, Revision of Pension / Family Pension in respect of Judicial Officers.

The Governor is pleased to order that -

1. the retirement benefits to Judicial Officers, who retire/ retired on or after 01.01.2006, shall be allowed as under: -

- Age of Superannuation:** - The age of Superannuation of Judicial Officers shall be as at present until further orders in this behalf are issued in the light of the directions of the Hon'ble Supreme Court in its Order dated 21.3.2002 in Writ Petition No.1022/1989.
- Qualifying service for earning full pension continues to be 33 years.
- Last pay drawn shall continue to be taken as emoluments for purpose of pension. The State Pension Rules shall continue to apply for calculation of pension.
- Commutation of pension shall be 50% of the pension with restoration after 15 years.
- There is no ceiling for maximum pension.
- The payment of DCRG and retirement Gratuity continues to be as per State Rules.
- Family Pension shall be determined as per State Rules.

The aforesaid provisions will come into force with effect from 01.01.2006 and will be applicable to Judicial Officers who have retired or ceased to be in service due to death or retirement on or after 01.01.2006.

2. the pension / family pension of the Judicial Officers who retired / died prior to 01.01.2006, may be revised as under: -

- The revised pension / family pension of the Judicial Officers who have retired or died while in service prior to 01.01.2006 shall constitute the following: -
  - Basic Pension / Family Pension as on 01.01.2006.
  - Dearness Pension @ 50% of original pension / family pension / consolidated pension / consolidated family pension under FD order No. F.6(3)FD(Rules)/2004 dated 24.05.2004, where applicable.
  - Dearness Relief @ 24% of original pension / family pension / consolidated pension / consolidated family pension plus Dearness Pension.
  - Fitment weightage @ 40% of the existing pension / family pension.

- (v) Where the existing pension in (i) above includes the effect of merger of 50% of dearness relief w.e.f. 01.07.2004, the existing pension for the purpose of fitment weightage will be recalculated after excluding the merged dearness relief of 50% from the pension.
- (b) The consolidated revised pension / family pension calculated as above shall not be less than 50% and 30% respectively of the minimum of the revised pay scale of the post held by the Judicial Officers at the time of retirement. The amount so arrived at will be regarded as consolidated pension / family pension with effect from 01.01.2006.
- (c) The revision in pension shall come into effect from 01.01.2006 and will be applicable to Judicial Officers who have retired or ceased to be in service due to death or retirement prior to 01.01.2006.


