Subject:- Rates of Dearness Allowance applicable w.e.f. 1.7.2008 to the employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised scale.

The undersigned is directed to say that this Department had issued orders on revised rates of Dearness Allowance based on AICPI(IW) index 2001 series for Central Government employees based on the revised scales of pay approved by the Government that came into effect from January, 1 2006 on acceptance of the recommendations of the 6th Central Pay Commission vide O.M.No.1(3)/2008-E.II(B) dated 29th August, 2008.

2. These rates however, are not applicable to the Central Government employees who had exercised an option to continue in the pre-revised scales of pay based on 5th CPC's recommendations or to those whose pay and allowance had not been revised, for different reasons in conformity with various Government decisions on the Commission's recommendations. The rates of DA w.e.f. 1.1.2008 for Central Government employees in pre-revised scale of pay were issued vide OM No.1 (1)/2008-E-II(B) dated 17th March, 2008

3. The rates of DA admissible to above categories of employees of Central Govt. and Central autonomous bodies shall be enhanced from the existing 47% to 54% w.e.f. 1.7.2008. All other terms and conditions contained in OM No.1(1)/2008-E-II (B) dated 17th March, 2008 shall continue to apply.

4. The contents of this Office Memorandum may also be brought to the notice of the organizations under the administrative control of the Ministries/Departments which have adopted the Central Government scales of pay.

MEMORANDUM

Subject: - Release of further installment of Dearness Relief @ 2% with effect from 1st July 2010 over the revised pension to the State Government pensioners/family pensioners.

The undersigned is directed to refer to this Department's Memorandum No.8(3)-FIN(G)/09 dated 5-5-2009, memo of even number dated 7th August, 2009 and memo No.F.8(3)-FIN(G)/09, dated 30-01-2010 on the above noted subject and to state that the Governor is pleased to decide grant of further installment of Dearness Relief @ 2% over the revised pension with effect from **1st July 2010** to the State Government Pensioners and Family Pensioners. With this release of installment, total quantum of Dearness Relief payable to the State Government Pensioners & Family Pensioners with effect from 1-7-2010 shall stand as 24% (22% + 2%) over the revised pension.

2. The amount of Dearness Relief shall be worked out in whole rupee. Fraction of a rupee below 50(fifty) paise shall be ignored, while fraction of rupee, 50(fifty) paise and above shall be rounded off to the next higher rupee.

3. The pension disbursing authorities including Public Sector Banks handling disbursement of pension/family pension to the State Government pensioners and family pensioners are authorized to calculate and disburse Dearness Relief at the above rates and manner from **1-7-2010**.

4. The expenditure on payment of Dearness Relief on Pension/Family pension to State Government pensioners and Family Pensioners is debit able to the Major Head '2071-Pension and other Retirement Benefits'
