Subject :- To provide joint account facility also to the pensioners of the Government of Uttar Pradesh.

Dear Sir,

On the above subject, I am directed to say that the scheme of payment of Pension through Public Sector Banks was implemented vide G.O. No-A-1-2480/X-10(10)/75, dated 01 January, 1979 which was withdrawn by G.O. No-A-1-1680/X-2001-10(23)/95, dated 19th July, 2001, and Jawahar Bhawan Pension Payment (JBPP) Scheme was introduced in all treasuries of the State. Under the scheme of JBPP the payment of the pension of the pensioners is being made by cheque to the pensioner's single saving bank account. The Government Of India has provided the facility of joint account to the pensioners and their spouse vide O.M. No-CPAO/Tech/Amendments/Sch.Book/2005-06/69, dated 9th Jun, 2005.

- 2- After due consideration it has now been decided for the convenience of the pensioners of Govt. of U.P. that like the pensioners of Government Of India the disbursment of pension to the pensioners of the State Government by single saving bank account

as well as joint account (spouse) . The joint account of the pensioner shall be operated by his wife or her husband under the following conditions:-

- (1) The liability of the Government will cease once pension has been credited to the pensioners bank account. There will no liability of the Government if the amount has been drawn in a irregular/erratic way by the spouse.
- (2) The information of death of the pensioner (wife or husband) shall have to be given to the treasury within a month in any case so that the treasury can stop the payment of pension in joint account. However if any amount wrongly credited in joint account of the pensioner, it may be recovered from joint account or any single name account hold by the pensioner. For the refund of the wrongly credited amount the heirs/legal heirs of the pensioners shall also be liable.
- (3) The above facility shall be applicable for existing and future pensioners.

3- The interested existing pensioners for joint account have to submit an application to related treasury & bank, from where they are drawing pension, for the payment of pension through joint account.

4- The above G.O. dated 9th July, 2001 read with G.O. 16th December 1996 and G.O. dated 06th April 1985 shall be deemed ammended to that extent. Other conditions shall be same.

छठे वेतन आयोग की संस्तुतियों को स्वीकार्य करते हुए भारत सरकार द्वारा संकल्प राजपत्र दिनांक 29 अगस्त, 2008 जारी किया गया है तथा इस परिप्रेक्ष्य में अखिल भारतीय सेवा के पेंशनरों / पारिवारिक पेंशनरों के बारे में कार्यालय - झाप संख्या -- 38/37/08-पी0पी0एण्डपी0डब्ल्यू(ए), दिनांक 01 सितम्बर, 2008 सम्मरस्यक्त कार्यालय - झाप दिनांक 02 सितम्बर, 2008 जारी करते हुए कार्यालय - झाप संख्या - 14021/7/2008 ए0आई0एस0(11), दिनांक 26 सितम्बर, 2008 जारी किये गये हैं। उक्त कार्यालय - झाप की प्रतियों सलमन करते हुए मुझे यह कहने का निदेश हुआ है कि कृपया अखिल भारतीय सेवा के पेंशनरों / पारिवारिक पेंशनरों को टेब पेंशन / पारिवारिक पेंशन का पुनरीक्षण उक्त कार्यालय - झाप में दी गयी व्यवस्था के अनुसार किया जाए। पुनरीक्षित पेंशन / पारिवारिक पेंशन का भुगतान दिनांक 01 जनवरी 2009 से प्रारम्भ होगा। पेंशन / पारिवारिक पेंशन अवधारणा का भुगतान 20 प्रतिशत 40 प्रतिशत एवं 40 प्रतिशत की 03 किशतों में किया जायेगा जिसमें से प्रथम किशत का भुगतान वित्तीय वर्ष 2008-09 के अन्तिम त्रैमास ( 01-11-2009 - 31-03-2009 ) में, द्वितीय किशत का भुगतान वित्तीय वर्ष 2009-10 में तथा तृतीय किशत का भुगतान वित्तीय वर्ष 2010-11 में किया जायेगा।
