Co-ordn./93/Vol-V/7 dated 19.4.2010 it is stated that Govt. of W.B., Finance Deptt. Pension Branch in their Memo no. 974-F (Pen), dated 26.11.2010 (copy enclosed) have sanctioned revised rates of dearness relief @ 35% wef 01-12-2010 payable on the basic pension in super session of the rates mentioned in the above circular dated 19.04.2010. Payment of relief on pension/family pension involving a fraction of a rupee shall be rounded off to the next higher Rupee. You are, therefore, requested to make necessary arrangements for payment of dearness relief at the rate as contained in the enclosed memo dated 26.11.2010 to all eligible West Bengal Govt. pensioner/family pensioner after proper adjustment. In this context, it is reiterated that separate circulars will be issued with regard to grant of dearness relief on pension/family pension to the teaching and non-teaching pensioner/family pensioners of Non-Govt. Educational Institution and Non Govt. Colleges on receipt of specific orders from the respective Administrative Departments. MEMORANDUM

Sub: Grant of Dearness Relief to State Government Pensioners /Family Pensioners with effect from December 1, 2010.

In continuation of this Department Memo No.290-F(Pen) dated 07.04.2010 sanctioning instalment of relief to the State Government Pensioners/Family Pensioners with effect from 01.04.2010 onwards, the undersigned is directed to state that the Governor is pleased to decide that the State Government Pensioners/Family Pensioners shall draw Dearness Relief @ 35% of basic pension with effect from December 1, 2010 onwards in supersession of the rates mentioned in the Order dated 07.04.2010 as mentioned above.

- 2. Payment of relief on Pension/Family Pension involving a fraction of rupee shall be rounded off to the next higher rupee.
- 3. It will now be the responsibility of the Pension Disbursing Authority to calculate the quantum of relief on Pension/Family Pension payable to each individual case.
- 4. For the purpose of payment of relief sanctioned herein, the Principal Accountant General (A&E), West Bengal will issue authority to the Public Sector Banks in Kolkata and the Accountant General of other States.
- 5. The Treasury/Sub-Treasury Officers in this State will give effect to this order without the authority of the Accountant General (A&E), West Bengal.
- 6. This benefit of Dearness Relief as has been sanctioned in the aforesaid Memorandum for the State Government Pensioners/Family Pensioners will also be allowed to the teaching and Nonteaching pensioners of State aided Non-Government Educational Institutions and Pensioners of Statutory Bodies/Government Undertakings/Panchayats including Panchayat Karmee and Municipal Corporations/Municipalities/Local Bodies etc. who are in receipt of Dearness Relief @ 27% of basic pension with effect from April 1, 2010. In such cases the respective Administrative Department may sanction the benefit of Dearness Relief @ 35% with effect from December 1, 2010 to the pensioners concerned under their control without making any further reference to Pension Branch of this Department.
- 7. It has also been decided that in the case of Public Undertakings/Statutory Bodies the additional expenditure should be borne by such Undertakings/Bodies themselves out of their own resources or out of financial assistance provided for them in the budget and that no additional financial assistance will be given to them on account of sanction of this instalment of Dearness Relief.

In continuation to this office circular No. Pen. Co-ordn./Bihar/Vol.- VIII/Revision/185 dated 18-03-2010, this is to state that the Govt. of Bihar in their Order No. 1161/B dated 09-07-2010 has stated that the second instalment (i.e. 40%) of arrears of pension with effect from 01-04-2007 to 31-08-2009, payable in the year 2010-11, shall be paid in the month of September 2010. 2. Having been authorized by the Accountant General (A&E) - II, Bihar in their letter No. Pen-IX-Spl.seal Authority No. 1343 dated 13-10-2010, it is requested to make necessary arrangements for payment of said 40% of arrears immediately, if not already paid. However, in regard to payment of remaining 45% of arrears (i.e. the third as well as the last instalment) of pension which will be paid in the year 2011-12 as per this office circular dated 18-03-2010 mentioned above, stands valid until further order in the matter. 3. Incidentally, it may be mentioned that this circular is issued to other Accountants General just to remind them the applicability of this order to the West Bengal Govt. pensioners/family pensioners guided by Bihar Pension Rules. 4. In this connection it may be stated here that the words 'this of the', appeared in the 7th line of para 4 of aforesaid circular erroneously, may please be read as 'benefit of this'. 5. The charges on this account for the pensioners/family pensioners of Govt. of Bihar are debitable to the Govt. of Bihar under the head "8793-I.S.S.A/cs.; Govt. of Bihar etc" and the charges for the West Bengal Govt. pensioners/family pensioners guided by Bihar Pension Rules are debitable to the Govt. of West Bengal under the head "2071-Pension and Other Retirement Benefits etc." Receipt of the circular may please be acknowledged. Subject:- Grant of Ex-gratia payment to the pensioners of Non-Govt. Colleges, Day Students' Home & West Bengal College Service Commission for the year 2010

Govt. of West Bengal, Higher Education Deptt., C.S. Branch in their Memo No. 806-Edn(CS)/ dated 12.10.2010 read with corrigendum No. 912-Edn(CS) dated 29.11.2010 have sanctioned payment of ex-gratia grant of Rs.400/- (Rupees four hundred) only in lump per head to all pensioners / family pensioners of Non-Govt Colleges, Day Students Home & West Bengal College Service Commission including the holders of provisional pension who retired prior to 30.09.2009 and also the pensioners who retired or died after 30.09.2009 but prior to 01.9.2010 and are not eligible to receive adhoc bonus .

- 2. The benefit will be admissible only to the pensioners/family pensioners whose basic pension/family pension alongwith relief did not exceed Rs.18000/-(Rupees eighteen thousand) as on 31st March 2010. The benefit is not admissible to those who are entitled to adhoc bonus and those who are employed / re-employed under any Public Undertaking / Statutory Bodies under the Government and are in receipt of bonus or exgratia payment in lieu thereof during the current year.
- 3. All concerned Pension Disbursing Officers are, therefore, requested to allow ex-gratia grant @ Rs.400/- (Rupees Four hundred) only to the above categories of pensioners / family pensioners keeping in view the instructions as mentioned above.
- 4. The charges on this account is debitable to the Head "2071-Pension and other retirement benefits 01-Civil-800-Other Expenditure".
- 5. In case of any doubt/difficulty, the matter may be referred to this office for clarification.
