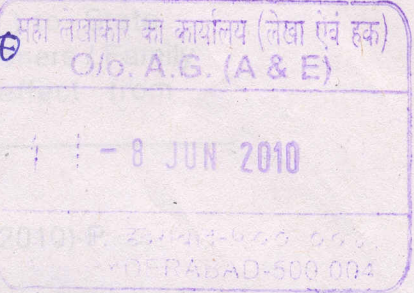

**RESOLUTION :**

The Government has decided to pay 27% Temporary Increase (Dearness Relief) to State Government Pensioners / Family Pensioners vide GR, FD,No. HGV-1009-512-P Dated 12/10/2009 Government has now decided to increase the rates of Temporary Increase (Dearness Relief) admissible to State Government Pensioners/Family Pensioners with effect from 01-01-2010 as under:

| Admissible From:                   | Admissible rate       |
|------------------------------------|-----------------------|
| Date 1 <sup>st</sup> January, 2010 | 35 % of Basic Pension |

1. Payment of Temporary Increase (Dearness Relief) involving a fraction of a rupee shall be rounded off to the next higher rupee.
2. Temporary Increase (Dearness Relief) at the rates indicated in above table will also be admissible on the additional basic pension/additional family pension available to older Pensioners/Family Pensioners based on their age as indicated in Government Resolution, Finance Department, No. PGR-1009-4-Pay Cell (M), dated 13<sup>th</sup> April 2009 and Government Resolution, Finance Department, No. PGR-1009-5-Pay Cell (M), dated 13<sup>th</sup> April 2009.
3. The amount of revised Temporary Increase with effect from-dated-01-01-2010 to the state Govt. Pensioners/Family Pensioners will be paid in cash.
4. It will be the responsibility of the Pension Disbursing Authority, to calculate the quantum of Dearness Relief payable in each individual case.

5. All Accountant Generals of the respective States/Central Administrative Authority except Gujarat State are requested to take necessary action to authorize all the disbursing authorities under their control for making payment to Gujarat Pensioners drawing pensions from their State Treasuries, including Public Sector Banks.
6. Other provisions governing grant of temporary Increase (Dearness Relief) to pensioners such as regulations of dearness relief during employment/ re-employment, regulations to temporary Increase (Dearness Relief), where more than one pension is drawn etc. will remain unchanged.



**RESOLUTION:**

The pensioners/family pensioners who are getting pension/family pension according to Pay Scales of Gujarat State Service (Revision of Pay), Rules, 1998 (Fifth Pay Commission) have been accorded temporary increase (T.I.) up to 64% vide Govt. Resolution No. HGV-2008-500-P, dated 10<sup>th</sup> Nov. 2009 read at No (ii) above.

2. Temporary Increase up to 9% has been accorded to the pensioners who are getting pension/family pension under Fifth Pay Commission as per the provision of Govt. of India, Office Memorandum dated 17.11.2009 read at No (iii) above. Accordingly, the Government of Gujarat has also decided to sanction temporary increase (T.I.) with effect from 01.07.2009 to the pensioners/family pensioners who are getting pension as per Fifth Pay Commission as under:

| Admissible from date | Admissible Rate                     |
|----------------------|-------------------------------------|
| 01.07.2009           | 73% of Basic Pension/Family Pension |

3. The Temporary Increase will be admissible on the amount of basic pension/family pension plus 50% of merged Dearness Relief as per the Govt. Resolution dated 5<sup>th</sup> January, 2010 read at No.(iv) above.

4. These Orders shall be applicable to Parvashi Pensioners and Jivai Pensioners also.

5. The amount payable as Temporary Increase shall be rounded off to the next rupee but an amount of less than 50 paise shall not be paid.

6. The arrears of difference payable under these Orders shall be paid in cash from 01.07.2009.



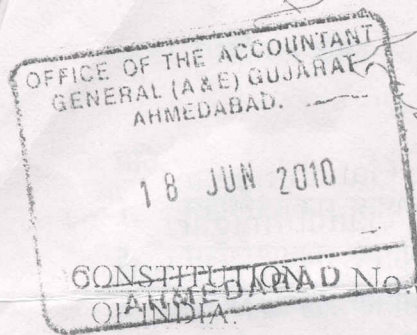

NOTIFICATION No. (GN-12) TJR-102010-28-Z :- In exercise of the powers conferred by clause (2) of article 283 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Gujarat Treasury Rules, 2000, namely :-

1. These rules may be called the Gujarat Treasury (Amendment) Rules, 2010.
2. In the Gujarat Treasury Rules, 2000, in rule 269, in sub-rule (7), in Note-1, for clause (II), the following shall be substituted, namely :-

“(ii) If the pensioner died after commencement of the payment of pension to him the concerned Mamlatdar or Mahalkari of the Taluka or Mahal or District, where the bank is situated, from which the amount of pension was last drawn by the pensioner, shall be competent to issue heir certificate for the payment of arrears or pension dues of the pensioner, without any financial limit.”
