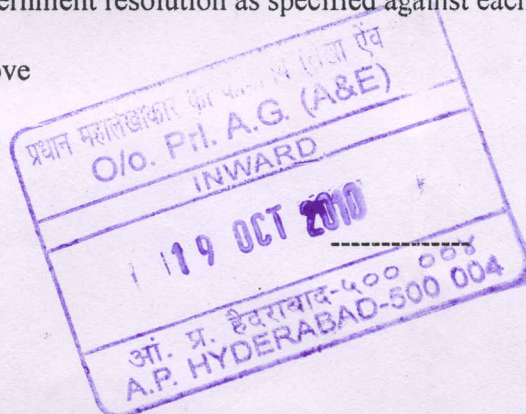

**RESOLUTION :**

The Government has decided to pay 35 % Temporary Increase (Dearness Relief) to State Government Pensioners / Family Pensioners vide GR, FD,No. HGV-1009-512-675(2010) P, Dated 30/04/2010 Government has now decided to increase the rates of Temporary Increase (Dearness Relief) admissible to State Government Pensioners/Family Pensioners with effect from 01-07-2010 as under:

Admissible From:	Admissible rate
Date 1 <sup>st</sup> July, 2010	45 % of Basic Pension

1. Payment of Temporary Increase (Dearness Relief) involving a fraction of a rupee shall be rounded off to the next higher rupee.
2. Temporary Increase (Dearness Relief) at the rates indicated in above table will also be admissible on the additional basic pension/additional family pension available to Pensioners/Family Pensioners based on their age as indicated in Government Resolution, Finance Department, No. PGR-1009-4-Pay Cell (M), dated 13<sup>th</sup> April 2009 and Government Resolution, Finance Department, No. PGR-1009-5-Pay Cell (M), dated 13<sup>th</sup> April 2009.
3. The amount of revised Temporary Increase with effect from-dated : 01-07-2010 to the state Govt. Pensioners/Family Pensioners will be paid in cash.
4. It will be the responsibility of the Pension Disbursing Authority, to calculate the quantum of Dearness Relief payable in each individual case.

5. All Accountant Generals of the respective States/Central Administrative Authority except Gujarat State are requested to take necessary action to authorize all the disbursing authorities under their control for making payment to Gujarat Pensioners drawing pensions from their State Treasuries, including Public Sector Banks.
6. Other provisions governing grant of temporary Increase (Dearness Relief) to pensioners such as regulations of dearness relief during employment/ re-employment, regulations to temporary Increase (Dearness Relief), where more than one pension is drawn etc. will remain unchanged.

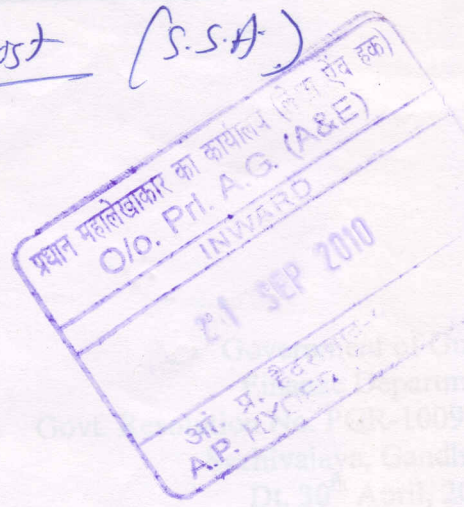

### Preamble

The State Government has substantially accepted the recommendations of the Sixth Central Pay Commission and has given its benefit to the employees of the State under Gujarat Civil Services (Revision of Pay) Rules, 2009 with effect from dt. 1-1-2006. Vide Finance Department G.R. quoted at Sr. No. (3) above, it was decided that the amount of arrears of the pay and allowances for the period from 1-1-2006 to 31-3-2009 shall be credited in the GPF A/c of the employees in five equal yearly installments of 20% each as an annual installment, after on-line verification of the pay fixation. Vide Finance Department Circular dated 18-1-2010, the first installment payable in the financial year 2009-10 was allowed to be credited in the GPF A/c of the employees without verification of pay fixation, subject to the condition that, on verification if any discrepancy noticed in the amount paid, shall be adjusted in the second installment of arrears,

Vide Finance Department Circular dated 11-3-2010, the first installment payable in the financial year 2009-10 to the employees of Board/ Corporation/ Grant in Aid institutions / employees/officers of Universities who hold CPF A/c, were allowed to be paid in cash without verification of pay fixation, subject to the condition that, on verification if any discrepancy noticed in the amount paid, shall be adjusted in the second installment of arrears.

As a part of the "Swarnim Gujarat Year" celebrations, the proposal of the payment of arrears payable to the employees/ officers in the financial year 2010-11 in cash in May, 2010, instead of crediting the same in their GPF A/c, was under the consideration of the Government. After careful consideration, the Government has decided the following.

officers as per the Sixth Pay Commission shall be paid in cash in May, 2010, instead of crediting the same in their GPF accounts.

It is also resolved that the second installment of the arrears of pension/pay payable to the pensioners shall be credited in their pension accounts.

It is further resolved that the employees/officers of the Board/ Corporation/ Grant in Aid institutions and employees/officers of Universities those who have been permitted by the Government for revision of pay as per the Sixth Pay Commission shall be paid the second installment of arrears payable in the financial year 2010-11 in May, 2010 in cash.

This payment is made subject to the condition that, on verification if any discrepancy noticed in the amount paid, shall be adjusted in the pay-allowances or remaining installments of arrears payable to the employees/officers.

All the Government Departments/ Heads of the Departments/ Heads of Offices are hereby instructed to take immediate action regard to this decision.

Other conditions/provisions of Finance Department Government Resolution No. PGR-1009-3-Pay Cell (M) dated 20-3-2009 shall remain unchanged.
