Sub:- Implementation of Government's decision on the recommendations of the Sixth Central Pay Commission – Revision of pension of Pre – 2006 pensioners / tamily pensioners.

The Government of Goa, Finance (Rev. & Cont.) Department Secretariat, Porvorim vide order No. 8/10/2008-Fin (R&C) dated 03-11-2008 has accorded the sanction of the Government of Goa to regulate Pension / family pension in accordance with the memorandum mentioned therein for revision of pension as recommended by Sixth Pay Commission and as accepted by the Government for the Pre - 2006 pensioners / family pensioners etc. The copy of the order is enclosed herewith for information and necessary action.

As regards to the Post 2006 pensioners Para – 11 of Office Memorandum dated 1st September 2008 may be referred. The separate individual orders will be issued to the Pension Disbursing Authorities for effecting the payment in this cases after revision of pension by this office.

Incase of Goa State Government pensioners drawing pension in other States, the instructions contained in above Office Memorandum may be issued to all the Treasuries / P.A.O. where the State Government Pensioners are drawing their monthly pension.

This order is not applicable to the following class of pensioners,

- (i) Freedom Fighters
- (ii) Pensioners drawing pension, which is granted after Independence for political consideration (Ex-Rulers)
- (iii) Pensioners of other States (PAO suspense) for whom separate orders are applicable.
- (iv) M.L.A. pensioners

Instruction issued from time to time by this office as regards to payment of relief should be observed.
