

2. The expenditure involved is debitable to the Head of Account "2071- Pension and other Retirement Benefits".



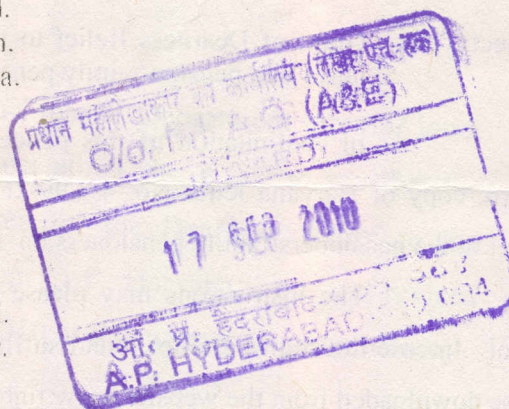
