ORDER NO. FD (Spl) 20 CPP 2010 BANGALORE, DATED 1st OCTOBER 2010

Government are pleased to sanction with effect from 1st July 2010 further increase in the rates of Dearness Allowance from the existing 46 % to 56.25% of basic pension/family pension to the State Government pensioners/family pensioners and pensioners/family pensioners of the aided educational institutions whose pension/family pension is paid out of the Consolidated Fund of the State.

This order shall not be applicable to pensioners who were drawing immediately before retirement pay in the UGC, AICTE and ICAR scales of pay and who retired on or after 1st July 2005. Separate Orders will be issued in repect of these pensioners.

The payment on account of the increase in dearness allowance as per this order involving fractions of 50 paise and above shall-be rounded off to the next rupee and fractions less than 50 paise shall be ignored.
