Sir, a set total enterent of the relation of the state of Sub: Revision of pension/family pension in respect of employees who Retired /expired while in service during the period from 1,3,2002 to 30.6.2004-reg Ref: GO(P) No.602/10/Fin dated 19.11.2010 (copy enclosed)

As per orders cited. Government of Kerala have sanctioned an increase of 5% in the existing monthly basic pension / family pension with effect from 1.4.2009 including those who draw minimum pension / family pension. While allowing such increase, the ceiling on maximum pension / family pension shall be ensured (ie, the pension shall not exceed Rs.16875 and the normal and higher rate of family pension shall not exceed Rs.10125 and Rs.16875 respectively).

As per these orders, the employees and teachers who retired / expired while in service on or after 1.7.2004 and drawing basic pension / family pension below Rs.2520 are eligible to get their basic pension / family pension fixed at Rs.2520 with effect from 1.4.2009. The enhanced pension is not commutable.

Applicability of the GO:

- 1. The 5% increase as per the orders will be applicable to the employees and teachers on State Government scales of pay who retired/expired while in service during the period from 1.3.2002 to 30.6.2004.
- 2. The enhancement of minimum pension / family pension to Rs.2520 is applicable to the employees and teachers on State Government scales of pay who retired/expired while in service on or after 1.7.2004.
- 3. These orders are not applicable to those coming under UGC /AICTE / Medical Education Scheme and Central Judicial Scales of pay.
- 4. These orders are also not applicable the teaching staff on State Government Scales of pay whose date of superannuation is prior to 1.3.2002.

Mechanism of revision: 4/31/9/AHTMAMAMAMAMATTI

As per Para 6 and 7 of the Government Order, the pensioners / family pensioners who are eligible to receive the benefits contemplated in the GO shall submit application in Appendix 11 to the Pension Disbursing Authority (Treasury / Bank) from where they are drawing pension after obtaining necessary certificate from the Pension Sanctioning Authority. After revision and disbursement of arrears, the Pension Disbursing Authority shall forward one copy of fixation statement to the Accountant General for updation of records.

In certain cases where retirement date of employees are yet to come, this office might have issued authorisations in advance. In such cases, if the authorised pension is less than Rs.2520, the Treasury Officers are directed to fix the basic pension at Rs.2520 with out waiting for revised orders from this office. Hereafter, in Pension Payment Orders issued, if rate of pension and family pension shown in page number 7 and 9 of the PPO are less than Rs.2520, the special noting in Page number 5 shall be the eligible basic pension/family pension with effect from 1.4.2009 or from date of commencement of the pension / family pension, whichever is later. While disbursing pension, the amount already commuted shall be reduced till the period of commutation over.

ORDER

As per the Government Order read above, Government have issued orders revising the pension/family pension in respect of State Government employees and teachers with effect from 1-4-2005, in accordance with the principles laid down therein, excluding those coming under UGC/AICTE/MES/Central Judicial Scale.

Representations have been received from various unions of service pensioners complaining that the employees and teachers who retired from service during the period from 1-3-2002 to 30-6-2004 did not get due benefit of pension revision as per the Government Order cited, since the Pay Revision 2004 was given effect only from 1-7-2004, subsequent to Pay Revision 1997, which came into effect from 1-3-1997.

Government in consultation with Accountant General (A&E) have examined the matter in detail and are pleased to issue the following orders:

1. These orders will be applicable to employees and teachers on State Government scales of pay who retired/expired while in service during the period from 1-3-2002 to 30-6-2004.

GCPT. 4/4481/2010/DTP.

- 2. An increase of 5% in the existing monthly basic pension/family pension will be allowed with effect from 1-4-2009 including those who draw minimum pension/family pension.
- 3. While allowing the increase, it shall be ensured that the ceiling on maximum pension will be observed i.e., the pension shall not exceed the prescribed limit.
- 4. In the case of employees and teachers who retired/expired while in service on or after 1-7-2004 and were drawing basic pension/family pension below Rs. 2520, their pension/family pension will be fixed at Rs. 2520.
- 5. The monetary benefit will be admissible with effect from 1-4-2009.
- 6. All the pensioners/family pensioners who are eligible for enhancement of pension under these orders shall submit the prescribed application (Pro forma appended) to the Pension Disbursing Authority through Pension Sanctioning Authority.
- 7. The Pension Sanctioning Authority after scrutiny and confirmation of the details furnished by the applicant shall forward the same to the Pension Disbursing Authorities concerned for further action.
- 8. Commutation shall not be allowed on the basis of the enhanced pension.
- 9. After revision of pension, the Pension Disbursing Authorities shall prepare a statement in the form appended to this order in triplicate and send one copy of the same to the Pensioner and one copy to the Accountant General (A&E), Kerala, Thiruvananthapuram for verification and updation of registers maintained by Accountant General.

These orders are not applicable to the teaching staff whose date of superannuation is prior to 1-3-2002.

Government of Kerala, as per GO cited have issued orders revising pension benefits of retired State Judicial Officers with effect from 1.1.2006. Pending clarification from Government on certain points, all Pension Disbursing Authorities are requested to admit revised benefits to the extent mentioned below.

Domestic Help Allowance

Domestic Help Allowance at the rate of Rs.2500/- per month is payable to the retired State Judicial Officers and at the rate of Rs.1000/- per month to the family pensioners with effect from 1.1.2006 or from the date of retirement which ever is later, on production of a self declaration to the effect that they have been incurring expenditure on that account, not less than the amounts mentioned above.

Medical Allowance

Medical Allowance at the rate of Rs.1500/- per month is payable to the retired State Judicial Officers and at the rate of Rs.750/- per month to the family pensioners with effect from 1.1.2006 or from the date of retirement which ever is later.

Conditions for payment of allowances

- (1) The arrears on account of revision of allowances shall be paid in two instalments. Sixty percent of arrears shall be paid before December, 2010 and the remaining 40% shall be paid before March, 2011.
- (2) The beneficiaries are eligible only for the difference between allowance payable and what has actually been paid.

(3) Pending clarification from Government, re-employed pensioners shall not be paid Domestic Help Allowance and Medical Allowance during their period of re-employment.

(4) The Life Time Arrears on Domestic Help Allowance due to a deceased pensioner shall be disbursed to his/her spouse on the strength of self declaration of the spouse to the effect that the pensioner had actually incurred the expenditure on that account. The Life Time Arrears on Medical Allowance shall also be disbursed to the spouse in the same manner. In the absence of spouse, arrears on allowances are not payable to other heirs.

All Pension Disbursing Authorities are directed to exhibit this pro-forma in their notice board for information of the pensioners.
