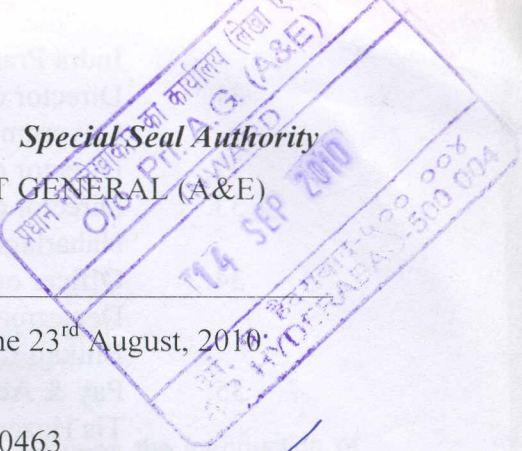



Subject :- Decision of the Government relating to grant of Dearness Relief to the State Government pensioners / family pensioners.

No. 9/4/2010-FD(PIC) : The undersigned is directed to say that consequent upon the introduction of Manipur Services (Revised Pay) Rules, 2010, the Governor of Manipur is pleased to order that the following rates of Dearness Relief shall be admissible to the pensioners / family pensioners of the State Government of Manipur with effect from 01/04/2010 :-

Date of Effect	Rate of Dearness Relief
01/01/2006	No Dearness Relief
01/07/2006	2 % of basic pension
01/01/2007	6 % of basic pension
01/07/2007	9 % of basic pension
01/01/2008	12 % of basic pension
01/07/2008	16 % of basic pension
01/01/2009	22 % of basic pension
01/07/2009	27 % of basic pension
01/01/2010	35 % of basic pension

2. The Dearness Relief at the rate indicated above will also be admissible on the additional basic pension / additional family pension available to older pensioners / family pensioners based on their age.
3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
4. Other provisions governing grant of Dearness Relief in respect of employed family pensioners and re-employed State Government pensioners and those relating to regulation of Dearness Relief where pensioners is in receipt of more than one pension will remain unchanged.
5. It will be the responsibility of the Pension Disbursing Authority, including the Nationalized Banks, etc. to calculate the quantum of Dearness Relief payable in each individual case.
6. The Accountant General (A&E), Manipur and the Authorized Public Sector Banks shall arrange payment of relief to pensioner etc., on the basis of the above instructions.


