### **OFFICE MEMORANDUM**

Subject:- Dearness Allowance.

The undersigned is directed to refer to this Department's O.M.No.F(PR)-47/2009/1 dated 17.9.2009 and to say that the Governor of Meghalaya is pleased to decide that the Dearness Allowance payable to the State government employees/pensioners/family pension holders shall be enhanced from the existing rate of 16% to 20% with effect from 1.7.2009.

2. These orders shall also apply to the members of the work-charged establishment and casual workers, other than Bungalow Peons, holding posts in the scales of pay as admissible to the employees of corresponding categories under the regular establishment/services/posts. These orders shall further apply to the teaching and non-teaching staff of the deficit institutions, including Primary Schools, as and when the revised pay scales applicable from 1.1.2007 are extended to them.

3. The Dearness Allowance under these orders shall remain suspended if the pensioners/family pension holders are employed/re-employed under the State/Central Government or employed/re-employed/permanently absorbed in the State or Central Government's Company, Corporation, Undertaking or Autonomous Body. It shall, however, be revived after the spell of such re-employment/employment.

4. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.

5. The payment on account of the Dearness Allowance sanctioned herein shall be debited to the respective heads of accounts from which the employees draw their salary and the pensioners/family pension holders, their pension.

The undersigned is directed to refer to this Department's Office Memorandum No.G.19011/24/2006-F.APF/129 dt. 28.4.2008 sanctioning the installment of Dearness Relief from 1.1.2008 @ 47% and to say that the Governor of Mizoram is pleased to decide that Dearness Relief paid to the Mizoram Government Pensioners and Family Pensioners shall be enhanced from the existing rate of Basic Pension with effect from 1.7.2008 @ 54% of Basic Pension (7%), 1.1.2009 @ 64% of Basic Pension (17%) and 1.7.2009 @ 73 % of Basic Pension (26%) respectively on the anology of the increased rate issued by the Government of Mizoram, Finance Department (PRU) to the employees of the Government of Mizoram vide Office Memorandum No.G.12017/2/2008-FIN (PRU) dt. 29.1.2010.

The enhanced Dearness Relief shall be released and paid in cash to all Pensioners and Family Pensioners of Government of Mizoram with effect from 1.7.2008 @ 7% 1.1.2009 @ 17% and 1.7.2009 @ 26% respectively. Payment of Dearness Relief involving a fraction of rupees

shall be rounded off to the next higher rupee.
