The Government of India have revised the rate of Dearness Relief on Pension/family Pension with effect from 01-01-2010 at the rate of 35% in their O.M.F.No.42/18/2010-P&PW(G), dated 31-03-2010 of the Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioner's Welfare, New Delhi.

- 2. The Government of Puducherry has communicated the Orders of Government of India for extending the revised rate of **Dearness Relief** @ 35% with effect from 01-01-2010 to the Pensioners/Family Pensioners of the Union Territory of Puducherry vide G.O.Ms.16/F3/2010, dated 16-04-2010 of the Finance Department, Puducherry.
- 3. I am therefore to authorize you to effect payment of Dearness Relief at the revised rate of 35% as mentioned above with effect from 01-01-2010 to all eligible Pensioners/Family Pensioners of Union Territory of Puducherry drawing Pension from the Banks/Treasuries/Sub-Treasuries under your control subject to conditions governing the payment of Dearness Relief on Pension/Family Pension as detailed in the Government of India Office Memorandum aforesaid.
