Sub: Grant of Special Festival Allowance to Kerala State Service Pensioners/Family Pensioners for the year 2016-17

Government of Kerala, as per GO(P) No.107/2017/Fin dated 16.8.2017 have sanctioned an amount of Rs.1000 as Special Festival Allowance to the following categories of Kerala State Service Pensioners/Family Pensioners:

- 1. Service pensioners
- 2. Family pensioners
- 3. Pro-rata pensioners
- 4. Pro-rata family pensioners
- 5. Ex-gratia pensioners
- 6. Ex-gratia family pensioners
- 7. Personal staff pensioners
- 8. Retired Leprosy Patient Employees
- 9. Part-time Contingent pensioners
- 10. Part-time Contingent family pensioners
- 11. Compassionate Allowance pensioners
- 12. Personal staff family pensioners

This allowance is admissible to those pensioners in respect of whom:

- 1. Pension commenced from a date prior to 1.4.2016 and
- 2. Pension commenced after 1.4.2016 but are not eligible for bonus or such other allowances as per the above Government Order for want of 6 months continuous service during the financial year 2016-2017. In their case, a self declaration to the effect that they are not

eligible for bonus or special festival allowance by virtue of their service during 2015-16 may be insisted upon before arranging payment.

The allowance sanctioned as per these orders shall be disbursed to the eligible Pensioners/Family Pensioners before 31.3.2018.

If a Service Pensioner is also in receipt of family pension, the special festival allowance is payable only on the basis of one of those pensions.

The special festival allowance sanctioned as per these orders is admissible to all State Pensioners/Family Pensioners except to the following categories.

- 1. All India Pensioners/Family Pensioners
- 2. Re-employed pensioners
- 3. Employed Family Pensioners
