Subject:- Grant of Ex-gratia payment to the pensioners/family pensioners of Non-Govt. Colleges, Day Students' Home & West Bengal College Service Commission for the year 2017

Govt. of West Bengal, Higher Education Department., C.S. Branch in their Memo No. 969-Edn(CS)/1P-20/98(Pt.1) dated 1/9/2017 have sanctioned payment of ex-gratia grant of Rs.1900/- (Rupees one thousand nine hundred) only in lump per head to all pensioners / family pensioners of Non-Govt. Colleges, Day Students' Home & West Bengal College Service Commission including the holders of provisional pension who retired prior to 30.09.2016 and also the pensioners who retired or died after 30.09.2016 but prior to 01.09.2017 and are not eligible to receive ad-hoc bonus .

- 2. The benefit will be admissible only to the pensioners/family pensioners whose basic pension/family pension along with relief as on 31st March 2017 did not exceed Rs.25000/-(Rupees twenty five thousand). The benefit is not admissible to those who are entitled to ad-hoc bonus and those who are employed / re-employed under any Public Undertaking / Statutory Bodies under the Government and are in receipt of bonus or ex-gratia payment in lieu thereof during the current financial year.
- 3. All concerned Pension Disbursing Officers are, therefore, requested to allow exgratia grant @ Rs.1900/- (Rupees One thousand nine hundred) only to the above categories of pensioners / family pensioners keeping in view the instructions as mentioned above.
- 4. In case of any doubt/difficulty, the matter may be referred to this office for clarification.
