Vide OM NO. DA/PEN/21/2009,dated 26/03/2013, it was decided that the fixation/revision of Pension/Family pension for those who retired/died prior to 1/1/2006 (Pre-2006 Pensioners/Family pensioners) shall be subject to the provision that the revised Pension/Family pension (Enhanced rate) shall not be less than 50% (Fifty percent) and family pension at ordinary rate @ 30% of the minimum of the pay in Pay Band plus Grade Pay corresponding to the prerevised pay scale from which the pensioners had retired/died, as arrived at with reference to the fitment tables provided for fixation of pay w.e.f. 1-1-2006, on the same line of the Government of India, Ministry of Personnel, PG & Pensions, Department of Pension and Pensioners' Welfare, New Delhi's clarificatory OM F.NO.38/37/08-P&PW(A) dated 28th January,2013. This OM was applicable w.e.f.24/9/2012.

Now, in partial modification of the above OM and with reference to the Government of India OM NO. 38/37/08-P&PW (A) Dated 30/07/2015, the Government of Arunachal Pradesh has decided that, the date of fixation/revision of Pre-2006 pensioners/Family pensioners be made applicable w.e.f. 01/01/2006 instead of 24/09/2012.

Other terms & conditions will be at par as indicated in Govt. of India's OM NO.38/37/08-P&PW (A) Dated 30/07/2015.
