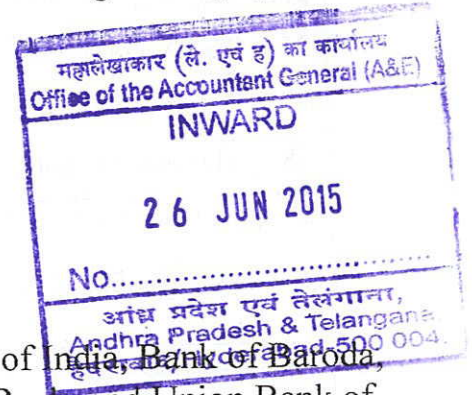

Sub: -Grant of Fixed Medical Allowances @ Rs. 500/- p.m to Goa Government Pensioners / Family Pensioners residing in area not covered by C.G.H.S w.e.f 01-06-2015.

1. The Government of Goa Finance (Revenue & Control) Department Secretariat Porvorim , Vide letter No. 8/6/99 Fin (R &C) FPC –Part File/387 dated 22-05-2015 has conveyed the sanction for revised Fixed Medical Allowance to the Pensioners / Family Pensioners of Goa Government as Contained in Government of India Office Memorandum No.4/25/2008-P & PW (D) dated 19-Nov 2014 issued by Government of India Ministry of Personnel, Public Grievances and Pension , Department of Pension and Pensioner welfare , New Delhi . The copy of the said memorandum is enclosed for information and necessary action.
2. Government of Goa is pleased to sanction the revised Fixed Medical Allowance of Rs 500/- p.m to state Government pensioner w.e.f. 01/06/2015.
3. The salient features of the Scheme are as follows:
 - (a). The Fixed Medical Allowances is applicable to pensioners/ family pensioners residing in areas not covered by C.G.H.S.
 - (b). The Fixed Medical Allowances is for Meeting Medical Expenses that do not require hospitalization.
 - (c). Re-employed pensioners, employed family pensioners, recipients of ex-gratia payment, freedom fighter pensioners and M.L.A pensioners are not entitled to Fixed Medical Allowances.
 - (d). Pensioners who are in receipts of two pensions are entitled to single Fixed Medical Allowances provided he/she does not avail of medical facilities for both pensions.
 - (e). Where family pension is shared by two persons, same criteria as in the case of Dearness Relief shall be followed.
 - (f). Payment shall be made alongwith pension/family pension.
 - (g). Specific entry shall be made in both portions of pension payment orders by the pension Disbursing Authority regarding grant of Fixed Medical Allowance.



Subject: Grant of Fixed Medical Allowance (FMA) to the Central
Government Pensioners residing in areas not covered under CGHS.

for their retired employees for meeting expenditure on their day-to-day medical expenses that do not require hospitalization. Orders were issued vide this Department's O.M. of even no. dated 26.05.2010 for enhancement of the amount of Fixed Medical Allowance from Rs. 100/- to Rs. 300/-p.m. w.e.f. 1.09.2008.

2. The demand for further enhancement of FMA has been under consideration of the Government for some time past. Sanction of the President is hereby conveyed for enhancement of the amount of Fixed Medical Allowance from Rs.300/- to Rs.500/- per month. The other conditions for grant of Fixed Medical Allowance shall continue to be as contained in this Department's OMs No.45/57/97-P&PW(C) dated 19.12.97, 24.8.98, 30.12.98 and 18.8.99.

3. These orders will take effect from date of issue of this O.M.

4. These orders are issued with the concurrence of the Ministry of Finance (Deptt. of Expenditure) vide their I.D. Note No 588/E.V/2014 dated 22.10.2014 and in consultation with the Comptroller and Auditor General of India vide their UO No. 174 Staff(Rules)/02-2011 dated 12.11.2014.
