Admissible From	Admissible rate
Date 1 st January, 2013	80 % of Basic Pension

- 1. Payment of Temporary Increase (Dearness Relief) involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 2. Temporary Increase (Dearness Relief) at the rates indicated in above table will also be admissible on the additional basic pension/additional family pension available to Pensioners/Family Pensioners base on their age as indicated in Government Resolution, Finance Department, No. PGR-1009-4-Pay Cell (M), dated 13 th April, 2009 and Government Resolution, Finance Department No. PGR-1009-5-Pay Cell (M), dated 13th April, 2009.
- 3. The amount of revised Temporary increase with effect from-dated: 01-01-2013 to the State Govt. Pensioners / Family Pensioners will be paid in cash.
- 4. It will be the responsibility of the Pension Disbursing Authority, to calculate the quantum of Dearness Relief payable in each individual case.
- 5. All Accountant General of the respective States/Central Administrative Authority except Gujarat State are requested to take necessary action to authorize all the disbursing authorities under their control for making payment to Gujarat Pensioners drawing pensions from their State Treasuries, Including Public Sector Banks.
