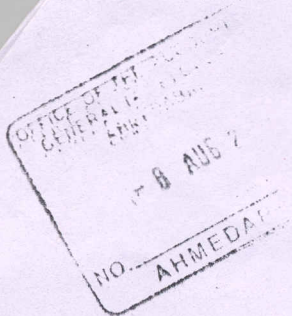

**RESOLUTION :**

As Per Finance Department's G.R. dated : 27-03-2012, the Government employees, retired between 01/01/2006 to 13/04/2009, were required to give an option regarding the pension according to fifth or sixth pay commission within 3 months i.e. up to 26th July, 2013. This time limit has already extended up to 26th July, 2013 by the State Government.

After careful consideration, the State Government has now decided to extend this time limit for further 3 months (up to 26th October, 2013) from 26th July, 2013.
