In pursuance of the decision of state government, the amount of difference of revised pension of nine (9) months from Dt.1/1/2016 to Dt.30/9/2016 is to be paid to the Pensioners / Family Pensioners of the state.

Considering the representations made by employees' associations/federations and pensioner's associations of the state regarding payment of the amount of difference of pay-pension, Honorable Deputy Chief Minister has, in the interest of the employees and pensioners of state government, taken a decision in the Legislative Assembly on Dt.1/3/2018 by making statement under Rule-44 of Legislative Assembly Rules to pay the above amount of difference in cash in three instalments during current year.

Resolution

In view of the above decision, it is decided to pay first installment of the amount of difference of 7th Pay Commission to the pensioners in March, second installment in May and third installment in July during current year.


