



**Subject:-** Implementation of Government's decision on Pension and Family Pension related matters-revision of pension of pre-1996 pensioners/family pensioners.

In continuation of FD's notification No. 1/2(8)98-2FR-II (Part-VIII) dated 7-1-2002, State Government has decided that at the end of para-6 of above mentioned notification, the following proviso is inserted namely:-

"Provided that the pension will be reduced pro-rata where the pensioner has less than the maximum required qualifying service for full pension as per rule in force at the time of retirement."
