

**Subject:- Reduction in the age of superannuation from 60 years to 58 years of Govt. Employees and from 62 years to 60 years in cases in cases of Group D employees.**

The Chief Secretary to Govt. Haryana vide Notification No.34/1/2004-4 GSI dated 26-11-2014(copy enclosed) has issued instructions regarding reduction in the age of superannuation (retirement) for Haryana Govt. employees from 60 years to 58 years except in the case of judicial officers. Similarly, the age of superannuation(retirement) for Class-IV employees reduced from 62 years to 60 years. These instructions will come into force with immediate effect. It is further decided that the employees who had reached to the superannuation age, but could not be retired till date due to enhanced superannuation age as per instructions dated 26-8-2014, will now be retired/superannuated on 30<sup>th</sup> November, 2014.

The instructions may please be issued to all the pension disbursing agencies under your control under intimation to this office. In case of more requirement, photocopies of the instructions may kindly be made or downloaded from the website of Government of Haryana([www.finhry.gov.in](http://www.finhry.gov.in)) to avoid delay in implementation of Government's decisions.
