

**Subject: -** Payment of arrears on account of revision of 1/3<sup>rd</sup> commuted portion of pension to those Govt. servants who had absorbed in PSUs/Autonomous Bodies.

In continuation to this Department's Office Memorandum of even number dated the 29<sup>th</sup> March, 2010, 2<sup>nd</sup> November, 2010, 10<sup>th</sup> March, 2011 and 17<sup>th</sup> August, 2011 on the subject cited above, the undersigned is directed to say that the Governor, Himachal Pradesh, is now pleased to order that the 50% of 1/3<sup>rd</sup> commuted portion of pension arrears upto 30-09-2009 accrued to the Pensioners (absorbees) w.e.f. 1.1.2006 or from the date of restoration of 1/3<sup>rd</sup> commuted portion of pension whichever, is latter to such pensioners (absorbees) may be released immediately. Thus, the total cumulative arrears released so far after taking into account the present release, shall amount to 75% of the total arrears to those Govt. servants who had been absorbed in PSUs/Autonomous Bodies.

3. In case of Pensioners (absorbees) who may have attained the age of 75 years as on 1.2.2012, the entire outstanding arrears of 1/3<sup>rd</sup> commuted portion of pension shall be paid in cash without observing the provision of para -1' ibid.



Now, the total cumulative arrears released so far after taking into account the present release, shall amount to 75% of the total arrears accrued to the Pre-2006 Pensioners/Family Pensioners.

It shall be the responsibility of the Pension Disbursing Authorities to ensure that extra amount, if any, in terms of para 2 of this Department O.M. of even number dated 29-3-2010 and 2-11-2010, is adjusted from the arrears of pension/family pension and only the balance amount may be paid to the Post-2006 Pensioners/ Family Pensioners.

The total cumulative arrears released so far after taking into account the present release, shall amount to 75% of the total arrears accrued to the Post-2006 Pensioners/Family Pensioners.

2. All the Drawing and Disbursing Officers of the Govt. Departments will ensure that the extra amount of Gratuity and Leave Encashment, if any, in terms of para-2 of this Department O.M. of even No. dated 29-3-2010 and para-3 of O.M. of even No. dated 2-11-2010 is adjusted from the arrears of respective elements and only balance amount may be paid to the Post-2006 Pensioners/Family Pensioners.

3. 
