## **OFFICE MEMORANDUM**

Subject.—Implementation of Government's decision on the recommendations of the Seventh Central Pay Commission in respect of All India Services - revision of pension of pre-2016 AIS pensioners/family pensioners and post-2016 AIS officers (retiree) of Himachal Pradesh cadre w.e.f. 1-1-2016.

The undersigned is directed to enclose herewith the Govt. of India's Office Memoranda No. F.No.38/37/2016-P&PW (A) (i) dated 4-8-2016 & No. F.No.38/37/2016-P&PW (A)(ii) dated 4-08-2016 and letter No. 14021/4/2016- AIS (II) dated 1-09-2016 regarding implementation of Government's decision on the recommendation of 7<sup>th</sup> Central Pay Commission, in respect of All India Services and to say that the pension/family pension of pre-2016 AIS-pensioners/family pensioners and the pension & other retirement benefits of the post 1-1-2016 retired All India Services Officers of the Himachal Pradesh cadre, shall be revised in accordance with the provisions of the aforesaid Office Memoranda.

- 2. All Pension Disbursing Authorities including Public sector Banks handling disbursement of pensions are requested to pay pension/family pension to pre-2016 pensioners/family pensioners in accordance with the provisions of the Govt. of India's Office Memorandum No. F.No.38/37/2016-P&PW (A)(ii) dated 4-08-2016.
- 3. Action to revise pension/family pension/commutation of pension/gratuity etc. in respect of AIS Officers of Himachal Pradesh retired on or after 1-1-2016 shall be initiated by the concerned Administrative Departments/Heads of Departments in accordance with Govt. of India O.M. No. F.No.38/37/2016-P&PW (A) (i) dated 4-8-2016 who will get the revised Pension Payment Orders (PPO's) issued accordingly.
- 4. Arrears of revised pension/family pension to pre-2016 AIS pensioners/family pensioners and the arrears of pension & other retirement benefits to post-2016 retired AIS Officers shall be paid lump-sum in one installment.
- 5. The Pension Allowance @5%, 10% and 15% to pre-2016- AIS pensioners of Himachal Pradesh Cadre, released vide Himachal Pradesh Government Office Memorandum No. Fin (Pen)A(3)-1/09 dated 23<sup>rd</sup> April, 2014, will be paid on the existing basic pension/family pension (*i.e. pre-revised pension/family pension*) only till further orders.
- 6. All the Pension Disbursing Authorities and Administrative Departments/Heads of Departments are requested to take further necessary action in accordance with the provisions of the aforesaid Office Memoranda which has already been sent by the Govt. of India to all the Pension Disbursing Authorities and Public Sector Banks.
