OFFICIAL MEMORANDUM

In Government Order No.FD (Spl) 27 PEN 2007, dated 13.10.2010 Government has enhanced the pension and family pension of the Government Servants who retired or died while in service prior to 01.07.1993 and who attained the age from 80 to 85, 85 to 90 and 90 years and above by 20%, 30% and 50% consecutively w.e.f. 1.4.2006.

In O.M.No.FD (Spl) 27 PEN 2007 dated 6.1.2011 it has been ordered that if the date of birth of the pensioner/family pensioner is not available in the Pension Payment Order the pension payment authority should intimate the pensioner/family pensioner about this and get from them any of the following documents duly attested by Gazetted Officer/MLA .

- 1. S.S.L.C. Certificate (containing the information regarding date of birth)
- 2. PAN card
- 3. Passport
- 4. Driving License (if it contains the date of birth)
- 5. Election I.D.Card

The Accountant General has in his letter dated 5.5.2011 stated that some of the family pensioners who are not in possession of any of the documents specified above are enquiring about the way to get the benefit of additional quantum of family pension as per the above said G.O, and has requested Government to examine the possibilities of prescribing some more alternative documents to be submitted by the family pensioner in support of their age proof. Government has examined this aspect and has ordered as below.

"In case the pensioner/ family pensioner is unable to submit any of the documents mentioned in the above said O.M. but claims additional pension based on some other documentary evidence, such cases will be submitted to the concerned Administrative Secretariat. If the Administrative Secretariat is satisfied about the claim of the pensioner/family pensioner, it will authorise additional pension/family pension accordingly. The decision of the Administrative Secretariat in this regard will be final.

However request for sanction of additional pension based on horoscope self certification (affidavit) or ID from private agencies shall not be considered.
