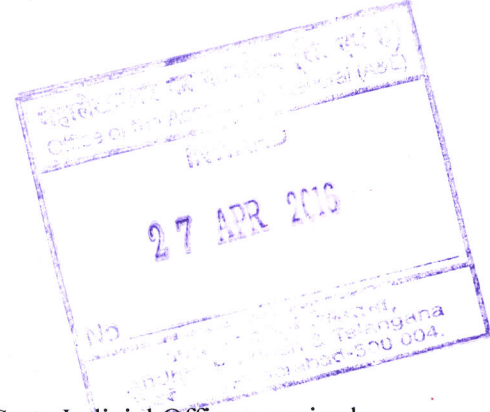

Sub: Grant of Dearness Relief to the retired State Judicial Officers-revised rate effective from 1.1.2016-reg

- Ref: 1. Office Memorandum F.No.42/06/2016-P&PW(G) dated 11.4.2016 of Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension and Pensioners Welfare.
2. GO(Ms) 55/2011/Home dated 24.2.2011

As per OM cited 1<sup>st</sup>, the Dearness Relief payable to Central Government pensioners/family pensioners has been enhanced from the existing rate of 119% to 125% with effect from 1.1.2016.

Government of Kerala as per orders cited 2<sup>nd</sup> have extended the benefit of increase in Dearness Relief sanctioned to Central Government pensioners/family pensioners to the retired State Judicial Officers/nominees without waiting for further orders from the State Government.

Hence, you are requested to honour the claim for enhanced Dearness Relief at the rate of 125% with effect from 1.1.2016, preferred by pensioners/family pensioners coming under the category of State Judicial Officers in respect of whom pension/family pension has been revised based on replacement scale came into force with effect from 1.1.2006.
