Introduction: -

Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training vide Memorandum No. 38/37/08-P & PW(A) dated 1.9.2008 had issued orders for revision of Pension/ Family Pension of Pre-2006 retired pensioners/ family pensioners as per decision taken by Central Government on the recommendations of 6th Pay Commission. Accordingly the orders to revise the pensionary benefits of All India services officers of Maharashtra Cadre were issued vide Government Resolution referred at Ref. No. 2 above. Subsequently Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training have issued Office Memorandum No. 38/37/08-P & PW(A) dated 28.1.2013 and dated 13.2.2013. In view of these revised orders, the pension/family pension of All India Services officers of Maharashtra Cadre who have retired before 1.1.2006 is to be revised accordingly. Consequently, the Government has taken the following decision.

Government Resolution :-


The amendments issued by the above referred Office Memorandum dated 28.1.2013 and 13.2.2013 will be applicable with necessary modifications to All India Services officers to whom the provisions of All India Service (Death cum Retirement Benefits) Rules, 1958 are applicable. The sanction of the Government is being given for action in respect of All India Services officers of Maharashtra Cadre who have retired before 1.1.2006. Accordingly following action may be taken to revise their pension/family pension.

Revision of Pension/ Family Pension of All India Services Officers who have retired before 1.1.2006 -

- 1. Pension Disbursing Authority (viz. Pay and Accounts Officer or District Treasury Officer) shall revise and disburse the Pension/ Family Pension of All India Services officers retired before 1.1.2006 as per the above referred office memorandum dated 28.1.2013 and dated 13.2.2013 and send the revised information in annexure III attached with the Memorandum dated 14.10.2008 issued by Central Government to the Office of Accountant General, Mumbai for obtaining the revised Pension Payment Order / Family Pension Payment Order and a copy to the concerned administrative department.
- 2. If there is no change in the pension/ family pension of All India Service pensioners/ family pensioners of Maharashtra Cadre as per OMs referred to above, then also Annexure-III may be sent to the Office of Accountant General, Mumbai and the concerned administrative department mentioning that there is no change in the pension/ family pension of concerned officer. In such cases, the office of the Accountant General, Mumbai shall also issue a revised PPO for no change.
- 3. Accordingly the pension/ family pension of All India Services officers retired before 1.1.2006 shall be revised. However, the arrears of revised pension/family pension shall not be admissible to the concerned officers for the period from 1.1.2006 to 23.9.2012. The disbursement of pension / family pension at revised rates shall be admissible only from 24.9.2012.
- 4. The expenditure on above account may be done from the budget head under which the expenses of pension of retired All India Service officers are incurred.
