The Governor is also pleased to order that concurrence of Finance Department shall be obtained by the concerned Departments for subsequent revision of the rates as and when sanctioned by the Ministry of Home Affairs, Government of India. The Department shall submit such cases of revision of rates alongwith the sanction orders of the Government of India. Such applications should also be invariably accompanied with the financial implications of the new rates.

It is further ordered that the Monetary allowance to pensioners or family pensioners of such awards as per relevant rules/conditions governing them shall be incorporated as a component in Pension Payment Order and it shall not be counted for the purpose of calculation of Dearness Relief. In the case of Gallantry Awardees at the time of retirement or death, the Head of Office shall clearly mention, while submitting the pension papers to Accounts & Treasuries, that the Government Servant is a recipient of such Gallantry awards with necessary details.
