Subject: - General Authority of enhanced rates of DA/ADA to employees of Nagaland Government w.e.f. 1-7-2011 from 51% to 58%

Sir,

In inviting a reference to the Government of Nagaland, Finance Deptt's O.M. NO.FIN/ROP/4/84(VOL-I) dated 09-06-2011, on the subject cited above, I am to authorized hereby for making payment of the enhanced rates of DA/ADA to Government employees of the state is detailed below with terms and conditions thereof-

- (i) Dearness Allowance for employees drawing Pay under ROF Rules 2010 w.e.f. 1-7-2011 31-12-2011 from the existing rate of 51% to 58% in the Pay Band including Grade Pay
- (ii) Dearness Allowance for employees drawing Pay under ROP Rules, 1999, w.e.f. 1-7-2011 from the existing rate of 115% to 127% of pay including Dearness Pay.
- (iii) Additional Dearness Allowance for employees drawing under ROP Rules, 1993, w.e.f. 1-7-2011 from the existing rate of 448% to 481% of pay.
- 2. The amount of DA/ADA shall be rounded off to the nearest rupes. Fraction of 50 paise and above shall be rounded off to the next higher rupee and the fraction less than 50 paise shall be ignored.
- 3. These order shall also apply to the employees appointed on contract against sanctioned Post, and drawing pay in identical scale applicable to the regular employees of the corresponding categories. But shall not apply to the work charge employees and any other categories of fixed pay. Daily wages.
- 4. The whole of the arrears from 1-7-2011 to 31-10-2011 shall be credited into the respective GPF/CPF accounts compulsorily and cash payment may be made from 1-11-2011 salary onwards. However, the employees who are superannuation on or before 30-4-2012 shall be exempted from these conditions.
- 5. The amount of arrears so credited to the provident funds shall be treated as accumulation for the purpose of Temporarily/non-refundable withdrawals till 28-2-2013 while sanctioning temporary/NRA from PFs, the sanctioning authority shall take care to exclude this lump sump credit till 28-2-2013. However, this condition shall not apply in case of final withdrawal in respect of retired./died Government employees.
- 6. Other terms a raditions may follow as laid down in O.M dated 1-11-2011 under reference.
