RESOLUTION

Subject: Revision of Pension / Family Pension in respect of the pre-2006 and post-2006 Pension and Family Pension holders of Orissa Judicial Service.

The Government of Odisha, after careful consideration of the direction of Hon'ble Supreme Court of India dated 28.01.2014 have been pleased to substitute the following provisions in para-5 and para-6; by partial modification of Finance Department Resolution No. 40733/F dated 22.9.2010.

5. Pre-2006 Pension / Family Pension holders of state Judicial Service:

- (a) Pension of judicial officer who retired/died prior to 01.01.2006 shall be revised in accordance with para 4 of Finance Department Office Memorandom No.3667/F Dt.19.1,2009 w.e.f 1.1.2006.
- (b) Provided that the revised full pension of all pensioners belonging to State Judicial Service relatable to the maximum period of qualifying service shall in no case be less than 50% of the minimum pay of the post held by him/her at the time of his/her retirement as revised from time to time.. The revised pay scales mentioned in the Law Department Resolution No.8318-VI-12/2010-L dt.2.8.2010 of the posts as on 1.1.2006 for State Judicial Service shall be taken into consideration for the above purpose w.e.f. 1.1.2006.
- (c) Similarly, the Family Pension of all Pre-2006 Family Pensioners belonging to the State Judicial Service shall not be less than 30% of the minimum pay in revised scale of pay as per Law Department Resolution No.8318-VI-12/2010-L dt.2.8.2010 for the post last held by the Pensioner/deceased officer belonging to the State Judicial Service w.e.f. 1.1.2006.
- (d) The provisions of additional Pension/Family pension and the Dearness Relief/T.I on additional Pension/Family pension as provided in para-12 & 13 of F.D O.M. No.3667/F dt.19.1.2009 respectively shall be applicable to the Pension/Family Pension holders of State Judicial Service w.e.f. 1.1.2006.
 - (e) There shall be no ceiling on maximum limit of Pension.
- (f) The expression "Pay Band and Grade Pay" used in F.D Resolution No.40733/F dt.22.09.2010 with reference to F.D O.M. No..3667/F dt.19.1.2009 for the purpose of calculation of Pension/Family Pension in respect of Pre-2006 Pensioners/Family Pensioners belonging to State Judicial Service shall be read as pay scale prescribed by the Law Department time to time.

Provisions laid down under para-5(2&3) of Finance Department Resolution No. 40733/F dated 22.9.2010 shall remain unaltered.

"6. Post-2006 Pension / Family Pension holders of state Judicial Service:

The expression "Pay Band and Grade Pay" used in F.D Resolution No.40733/F dt.22.09.2010 with reference to F.D O.M. No..3667/F dt.19.1.2009 for the purpose of Pension and Pensionary benefits in respect of Post-2006 Pension/Family Pension holders of State Judicial Service shall be read as pay scale applicable to them vide Law Department Resolution No. 8318-VI-12/2010-L dt.2.8.2010 commencing from 1.1.2006."

All other provisions laid down under para-6 of Finance Department Resolution No. 40733/F dated 22.9.2010 shall remain unaltered.
