Sub: Grant of Dearness Relief to Pensioners and Family Pensioners of Union Territory of Puducherry – Revised rates effective from 01-01-2012 – Reg.

The Government of India have revised the rate of Dearness Relief on Pension/family Pension with effect from 01-01-2012 at the rate of 65% in O.M.F.No.42/13/2012-P&PW(G), dt. 04-04-2012 of the Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioners' Welfare, New Delhi.

- 2. The Government of Puducherry has communicated the Orders of Government of India for extending the revised rate of Dearness Relief @ 65% with effect from 01-01-2012 to the Pensioners/Family Pensioners of the Union Territory of Puducherry vide G.O.Ms.No.5/F3/2012-13, dated 19-04-2012 of the Finance Department, Puducherry.
- 3. I am therefore to authorize you to effect payment of Dearness Relief at the revised rate of 65% as mentioned above with effect from 01-01-2012 to all eligible Pensioners/Family Pensioners of Union Territory of Puducherry drawing Pension from the Banks/Treasuries/Sub-Treasuries under your control subject to conditions governing the payment of Dearness Relief on Pension/Family Pension as detailed in the Government of India Office Memorandum aforesaid.
