

Subject : Regarding recovery of Commuted Value of Pension.

1 am directed to invite your attention to the letter No. T&A/DDI/D-2/2024/4051, dated 28.06.2024, letter no. 03/02/2024-3FPPC/328, dated 29.08.2024, T&A/DDI/D-2/2024/6362 dated 23.09.2024 on the subject cited above.

- 2. In compliance to the Interim order passed by Hon'ble Punjab and Haryana High court in various CWPs, the recovery of commuted value of pension from all the pensioners of State Government who have completed 10 years of retirement or above was stayed till the vacation of stay orders.
- 3. Now Hon, ble Court has decided this matter and passed the orders in CWP 9426 of 2023 titled as Shila Devi and others and other connected petitions on 27.11.2024. The relevant portion of the orders of the Hon'ble Court is as under:-
 - "30. Keeping in view the fair stand on the part of the State, we do not find any ground for issuance of any particular direction in this regard except to observe that in terms of the stand as projected before us, it is expected that necessary steps in this regard would be taken expeditiously by the State.
 - 31. Keeping in view facts and circumstances as narrated and discussed in foregoing paras, all the 808 writ petitions are dismissed with no order as to cost. It is clarified that the State is entitled to effect recoveries which were stayed by way of interim orders in the writ petitions. Such recovery however be made in a staggered manner to obviate any hardship to the pensioners."
 - 4. Now, keeping in view the above orders of the Hon'ble Court, the Government has decided to restart the recovery process. The amount of recovery which could not take place due to stay orders will now be made in a

staggered manner i.e it will be recovered within the same time frame for which the recovery was stayed. For example, if the due recovery was not made for 06 months, it will now be recovered over the next 06 months in addition to the regular repayment of commuted value of pension. It is further clarified the normal recovery of commuted portion of pension will continue simultaneously.

The compliance of these instructions shall be ensured by all the Pension Disbursing Banks and any deviation shall be taken as deliberate non compliance of these instructions.



I am directed to invite your attention to the letter No. T&A/DDI/D-2/2024/4051 dated 28.06.2024 on the subject cited above.

- 2. In compliance to the interim order passed by Hon'ble Punjab and Haryana High Court in various CWPs, the necessary directions to stop the recovery of Commuted Value of Pension till the vacation of stay orders, from pensioners (Petitioners in CWPs) have already been issued as per letter mentioned above.
- 3. In order to avoid further litigation in the matter, State Government has now considered the issue and decided to stop the recovery of Commuted Value of Pension till the vacation of Stay Orders, from all pensioners (including Petitioners) of State Government who have completed 10 years of retirement or above.
