



Sir/Madam,

I am directed to inform you that the Government has decided to pay the arrears of the revised pay/pension, Leave Encashment and Gratuity to the employees/Pensioners of Govt./Aided Schools and college, employees as per 6th PPC, UGC, AICTE revised pay scales as mentioned below:-

(a) Arrear of revised pay/pension and leave encashment to the employees/pensioners of Govt./Aided Schools and colleges/Universities etc. as per 6th PPC, UGC, AICTE etc. for the period <u>01.01.2016</u> to <u>30.06.2021</u> will be paid as per the plan already approval by the Cabinet for the State Government employees/pensioners in the meeting held on 13.02.2025 and instructions in this regard were issued by the FD vide letter No. 03/01/2021-1FP1/12, dated 18.02.2025. (b) Arrear of revised pay/pension to the pensioners/employees of aided schools (from 01.07.2021 to 30.06.2024), for government colleges, universities, etc. as per the 6th Pay Commission, UGC and AICTE, for the period from 01.07.2021 until the revised pension/pay is paid (in cash), will be paid in eight equal quarterly installment. The first 04 installments will be paid in the financial year 2026-27 and the next 04 installment will be paid in the financial year 2027-2028 as under:-
