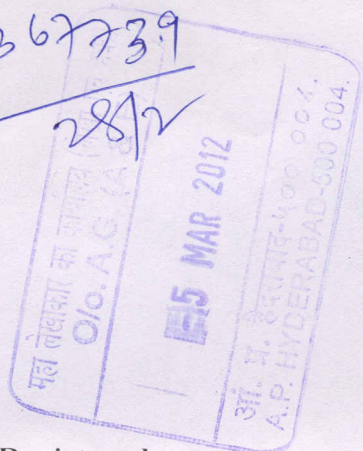

Subject :- Grant of Ex-gratia.

Sir/Madam,

I am directed to invite a reference to the subject cited above and to say that after careful consideration of the recommendations contained in paras 6.55 to 6.60 of the report of the Fifth Punjab Pay Commission and in partial modification of instructions contained in letter No. 3/19/10-3FPPC/1251, dated the 13th October, 2010, the Governor of Punjab is pleased to decide that in case of accidental or homicidal death of an employee during the performance of duty, his legal heirs will be entitled to a lump sum payment of Rs. 5.00 lacs as Ex-Gratia amount. However, the Ex-Gratia grant envisaged in these orders shall not be admissible in the case of those Government employees who commit suicide during the performance of duty.

2. The Ex-gratia grant envisaged in these orders shall not be linked to the basic pay or the group of the employee concerned.
3. It has been further decided that the full amount of Ex-gratia payment admissible under these orders shall also be payable to those employees who incur complete permanent disability during the performance of duty rendering them unfit for further service. In the case of those employees who incur partial permanent disability during the performance of duty, Ex-gratia payable under these orders shall be proportionate to the percentage of partial permanent disability incurred by him.
4. These orders shall come into force with effect from 1st December, 2011.
5. The instructions contained in para 8(b) of the letter under reference shall be deemed to have been amended accordingly.
6. The necessary amendments in the rules shall be made in due course.
7. Punjabi version of this letter will follow in due course.







Subject: - Regarding entitlement of enhanced family pension payable to the family of a Government employee who dies in harness.

Sir/Madam,

I am directed to invite a reference to Government letter no. 3/39/09-3FPPC/944, dated the 25th July, 2011, on the subject cited above and to say that the Governor of Punjab is pleased to decide further as under:-

2. The rate of family pension in respect of employees who die in harness, during the first fifteen years from the date of death or till the Government employee would have attained the age of sixty five had he survived, whichever period is less, shall be as follows :-

Pay in the Revised Pay Structure	Rate of Enhanced Family Pension per
Pay upto Rs. 10,000	60% of pay
Pay above Rs. 10,000	50% of pay subject to minimum of Rs. 6000

3. The rate of family pension in respect of employees who die in harness, after first fifteen years from the date of his death or till the Government employee would have attained the age of sixty five had he survived, whichever period is less, shall be as follows :-

Pay in the Revised Pay Structure	Rate of Enhanced Family Pension per mensem
Pay upto Rs. 10,000	40% of pay
Pay above Rs. 10,000	30% of pay subject to minimum of Rs. 4000

4. These enhanced rates mentioned in para 2 above shall not apply in those cases where the period of ten years for payment of enhanced family pension, in terms of para 2 of the letter under reference, stood completed before the first day of December, 2011 and the family was receiving family pension at the rates mentioned in para 3 thereof.


5. These orders shall come into force w.e.f. 01.12.2011.

6. The other provisions of the letter under reference shall remain unchanged.

7. Necessary amendment(s) in the rules will be made in due course.






Sir/Madam,

I am directed to invite a reference to Government letter No. 3/23/09-3FPPC/879, dated 17th August, 2009, on the subject cited above and to say that the Governor of Punjab is pleased to decide that the quantum of pension available to the old pensioners/family pensioners, shall be further increased as under :-

Age of pensioner/family pensioner	Additional quantum of pension/family pension
From 65 years to less than 70 years	5 per cent of revised basic pension/family pension
From 70 years to less than 75 years	10 per cent of revised basic pension/family pension
From 75 years to less than 80 years	15 per cent of revised basic pension/family pension
From 80 years to less than 85 years	25 per cent of revised basic pension/family pension
From 85 years to less than 90 years	35 per cent of revised basic pension/family pension
From 90 years to less than 95 years	45 per cent of revised basic pension/family pension
From 95 years to less than 100 years	55 per cent of revised basic pension/family pension
100 years or more	100 per cent of revised basic pension/family pension

2. These orders shall come into force with effect from 1st December, 2011. The enhanced rates shall be applicable prospectively and there shall be no element, whatsoever, of retrospectivity in this regard and there shall be no question of payment of arrears or of national benefits from any previous date.
3. The other terms and conditions regarding grant of pension and other retirement benefits shall remain unchanged.
4. Necessary amendments in rules shall be made in due course.
5. Punjabi version of these orders shall follow in due course.




