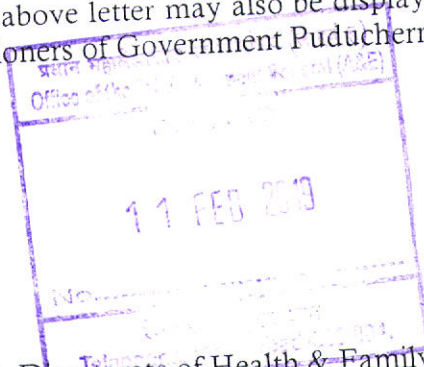

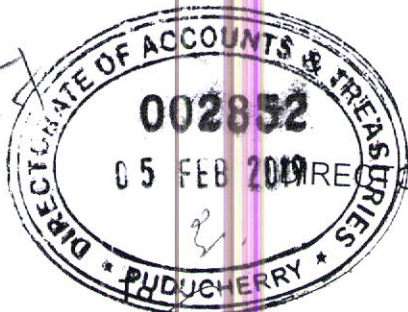

Sub: DHFWS – Contributory Medical Benefit Scheme for the Retired Government Employees and their spouses in Union Territory of Puducherry Enrollment of Retired Pensioners who retired after April, 2018–Called for–Reg.

Ref: 1. G.O.Ms. No. 12 dated 19-04-2018 of the Under Secretary to Government (Health), Chief Secretariat, Puducherry.
2. Lr.No.20892/DHFWS/SAO/H1/MA/2016-17/208 dated 04-09-2018 from the Director of Health & Family Welfare Services, Puducherry.

I am to inform that, off late representations are received from various Pensioners Association/ Retired persons that they are not aware of the Scheme that the Officials Retired after April, 2018 may also enroll in the Contributory Medical Benefit Scheme and requested to enroll them in the Scheme.

After due consideration of the Government, it has been decided that the Officials retired after April, 2018 (i.e. Pensioners with effect from May, 2018) may enroll in the Scheme with payment of entire premium (deduction from the pension payable of the concerned month) of ₹4,248/- (Rupees Four thousand two hundred and forty eight) for prorata period for the 1st year as a onetime measure till 30th April, 2019 by relaxing the instruction issued vide reference 2nd cited. The deduction of subsequent premium for the 2nd & 3rd year shall be as per the G.O. 1st cited above.

The Director of Accounts and Treasuries, Puducherry is requested to circulate the same to all the Treasuries/ Sub Treasuries / All Banks for information to the Pensioners.
