ORDER:

The Government sanction a lumpsum Pongal Prize of Rs.500/-(Rupees Five hundred only) to all Government Pensioners/Family Pensioners including Pensioners/Family Pensioners of All India Services, Aided Educational Institutions, Local Bodies, Ex-Village Establishment and adhoc Pensioners of all categories.

- **2.** This order shall also be applicable to Provisional pensioners. The Pongal Prize shall not be admissible to those employees who retire on or after 11-01-2017 and to the families of those employees who die in harness on or after 11-01-2017.
- **3.** Those who have retired / died in harness during the period from 01-10-2015 to 10-01-2017 are not eligible for the Pongal Prize amount if they are paid Adhoc Bonus / Special Adhoc Bonus as per the orders issued in the Government Order second read above. For this purpose, the Pension Disbursing Officers shall obtain non-drawal certificates from the departments concerned before making payment to such Pensioners.
- **4.** This order is not applicable to the following categories of pensioners:-
 - (i) Special Pensioners such as Ulema Pensioners, State Freedom Fighter Pensioners and Scholars and Eminent persons, etc., covered by Social Pension Scheme
 - (ii) Family Pensioners who are appointed on compassionate grounds and received adhoc bonus / special adhoc bonus as applicable to the serving employees.

- **5.** The Government also direct that the procedure indicated below be followed for disbursement of Pongal Prize in respect of Pensioners / Family Pensioners coming under the Pension Pilot Scheme;
 - (i) In respect of those Pensioners / Family Pensioners to whom pension / family pension is sent by Money Order at Government cost, the Pongal prize amount also shall be sent by Money Order at Government cost.
 - (ii) In respect of Pensioners / Family Pensioners to whom pension / family pension is paid through Banks,
 - (a) In Pension Pay Office, Chennai and District Treasuries / Sub-Treasuries where the cheque system of payment of bills / Electronic Clearing System is in vogue, the Pension Pay Officer, Chennai and District Treasury officers / Sub Treasury officers are permitted to issue cheques and send the cheques to the respective paying branches of the bank with a list of Pensioners / Family Pensioners for crediting the amount to the pensioners' / family pensioners' savings bank account.
 - (b) As regards Banking Sub-Treasuries where the cheque system of payment of bills / Electronic Clearing System is not in vogue, the Sub Treasury officers are permitted to get Banker's Cheque / Demand Draft and send them to the respective Pensioners for crediting the amount to the pensioners' / family pensioners' savings bank account.
- **6.** In respect of Pensioners / Family Pensioners coming under the Public Sector Bank Scheme, all Public Sector Banks are authorised to credit the amount to the pensioners' / family pensioners' account.
- **7.** In respect of Pensioners / Family Pensioners for whom expenditure is met from State Consolidated Fund, the expenditure shall be debited to the following Head of Account:
 - "2071. Pensions and Other Retirement Benefits 01. Civil 800. Other Expenditure I. Non-Plan AF. Pongal Prize to Pensioners and Family Pensioners 27. Pensions 09. Others (D.P.C. 2071 01 800 AF 2799)".

In respect of payment of Pongal Prize to Ex-Village Officers, the expenditure shall be debited to the following Head of Account:-

- "2071. Pensions and Other Retirement Benefits 01. Civil 800. Other Expenditure I. Non-Plan AK. Other Expenditure Pongal Prize to Ex-Village Officers 27. Pensions 09. Others (D.P.C. 2071 01 800 AK 2799)".
- **8.** In respect of Pensioners / Family Pensioners of Local Bodies for whom expenditure is met from the fund maintained by the Director of Local Fund Audit or Municipal Funds, as the case may be, the expenditure shall be met from the respective fund referred to above.

- **9.** The Pongal Prize amount sanctioned above shall be paid to the eligible Pensioners / Family Pensioners and Ex-Village Officers immediately.
- 10. Necessary funds are provided under the relevant head of account in Revised Budget Estimate 2016-2017. However, additional funds, if any required will be provided in RE/FMA 2016-2017 and the required amount shall be drawn pending provision of such additional fund.
- 11. This order issues with the Additional Sanction Ledger No.1875 (One Thousand Eight Hundred and Seventy Five).

OFFICE MEMORANDUM

Subject: - Grant of Dearness Relief to Himachal Pradesh Government Pensioners/Family Pensioners-Revised rate effective from 01-07-2016.

The undersigned is directed to refer to this department's O.M. No. Fin (Pen)B(10)-6/98-III, dated 3rd October, 2016 sanctioning one instalment of dearness relief with effect from 01-01-2016 and to say that the Governor, Himachal Pradesh is pleased to decide that dearness relief payable to the Himachal Pradesh Government Pensioners/Family Pensioners shall be enhanced from existing rate of 125 % to 127 % w.e.f. 01-07-2016.

- 2. Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 3. Other provisions governing grant of dearness relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., will remain unchanged. However, in the event of revision of pension/family pension the dearness relief @2% will be admissible on revised basic pension/basic family pension and the difference will be paid in the shape of arrears to the pensioners/family pensioners.
- 4. These orders shall apply to all H.P. Government Pensioners/ Family pensioners.
- 5. As dearness relief will now be at a uniform rate, it has been decided to dispense with the issue of enclosing ready reckoner alongwith the dearness relief orders. It will be the responsibility of the pension disbursing authority, including the Nationalized Banks, etc. to calculate the quantum of dearness relief payable in each individual case.
- 6. The Dearness Relief on basic pension & basic family pension @ 127 % will be paid with the pension/family pension for the month of January, 2017 payable in the month of February, 2017. The arrears accrued on account of dearness relief w.e.f 01-7-2016 to 31-12-2016 shall be paid in cash in one instalment along with pension /family pension for the month of January, 2017 payable in month of February, 2017.
- 7. The Accountant General, Treasury Officers and authorized Public Sector Banks are requested to arrange the payment of Dearness Relief to pensioners on the basis of these orders.

विषय : राज्य सरकार के पेंशन / पारिवारिक पेंशनभोगियों को 01 जुलाई, 2016 के प्रभाव से महँगाई राहत की दरों में अभिवृद्धि के संबंध में।

वित्त विभाग के संकल्प संख्या 660/वि•, दिनांक 28.02.2009 के द्वारा राज्य सरकार के पेंशनधारियों/पारिवारिक पेंशनभोगियों को केन्द्र सरकार के पेंशनधारियों/पारिवारिक पेंशनभोगियों की भांति दिनांक 01.01.2006 के प्रभाव से पुनरीक्षित केन्द्रीय पेंशन/पारिवारिक पेंशन की स्वीकृति प्रदान की गई है। उक्त संकल्प की कंडिका—17 (ए०)(बी०) के अनुसार पेंशनधारियों/पारिवारिक पेंशनभोगियों को केन्द्रीय दर पर महँगाई राहत स्वीकृत किया गया है।

- 2. उपर्युक्त के अनुसार केन्द्र सरकार के पेंशनभोगियों के भांति दिनांक 01.01.2006 से राज्य सरकार के पेंशनधारियों / पारिवारिक पेंशनभोगियों को भी महँगाई राहत अनुमान्य किया जाता है। वर्तमान में राज्य सरकार के पेंशनधारियों / पारिवारिक पेंशनभोगी 125% (एक सौ पच्चीस प्रतिशत) महँगाई राहत प्राप्त कर रहे हैं।
- 3. केन्द्र सरकार के द्वारा अपने पंशनधारियों / पारिवारिक पेंशनधारियों को दिनांक 01.01.2016 के प्रभाव से सप्तम वेतन पुनरीक्षण का लाम के अनुरूप पेंशन का पुनरीक्षण किया गया है और उसके आलोक में कार्मिक, लोक शिकायत एवं पेंशन मंत्रालय, भारत सरकार के पत्र संख्या F.No. 42/15/2016- P& PW(G) दिनांक 16.11.2016 के द्वारा दिनांक 01.07.2016 के प्रभाव से सप्तम पुनरीक्षित पेंशन में मूल पेंशन का 2% महँगाई राहत की स्वीकृति प्रदान की गई है, सम्प्रति झारखण्ड राज्य में पेंशनधारी / पारिवारिक पेंशनधारी छठे वेतन पुनरीक्षण के अनुरूप पेंशन का लाभ प्राप्त कर रहे हैं।
- 4. भारत सरकार वित्त मंत्रालय के कार्यालय ज्ञाप सं. 1/3/2008-E(II)(B) दिनांक 09.11.2016 के द्वारा अपुनरीक्षित वेतनमान में वेतन प्राप्त कर रहे केन्द्रीय कर्मियों को दिनांक 01.07.2016 के प्रभाव से महँगाई भत्ता की दर 125% (एक सौ पच्चीस प्रतिशत) से बढ़ाकर 132% (एक सौ बत्तीस प्रतिशत) स्वीकृत किया गया है। राज्य सरकार के द्वारा वित्त विभागीय संकल्प संख्या 3504/वि. दिनांक 08.12.2016 द्वारा अपने कर्मियों के लिए दिनांक 01.07.2016 के प्रभाव से महँगाई भत्ता की दर 132% (एक सौ बत्तीस प्रतिशत) स्वीकृत की जा चुकी है। राज्य सरकार अपने कर्मियों के साध— साध पंशनभोगियों/ पारिवारिक पंशनभोगियों को भी महँगाई राहत की स्वीकृति केन्द्र सरकार के अनुरूप समान दर एवं समान तिथि से करती रही है।
- 5. अतः उपर्युक्त पृष्टभूमि में राज्य सरकार ने सम्यक् विचारोपरांत राज्य के पेंशनधारियों / पारिवारिक पेंशनभोगियों को दिनांक 01.07.2016 के प्रभाव से महँगाई राहत 125% (एक सौ पच्चीस प्रतिशत) से बढ़ाकर 132% (एक सौ बत्तीस प्रतिशत) किये जाने का निर्णय लिया है।
- 6. उक्त दर पर महँगाई राहत की गणना पुनरीक्षित पेंशन अथवा दिनांक 01.01.2006 के पश्चात् सेवानिवृत्त के समय प्राधिकृत पेंशन के समेकित पेंशन राशि पर किया जायेगा।

- 7. महँगाई राहत की स्वीकृति के कारण भुगतेय रशि में यदि 50 पैसे या उस् गणना आती हो, तो अगले उच्चतर रुपये में इसे पूर्णांकित किया जायेगा और 50 पैसे से कम को छोड़ दिया जायेगा।
- 8. पेंशन/पारिवारिक पेंशन पर आदेय महँगाई राहत का भुगतान करते समय वित्त विभा परिपन्न संख्या 3556/वि•, दिनांक 09.05.1991 में समाविष्ट निदेशों का अनुपालन किया जाना अनि होगा। उक्त रिथतियों को छोड़कर महँगाई राहत शेष सभी असैनिक पेंशनभोगियों को देय होगा, जि क्षितिपूर्ति/बार्धक्य निवृत्ति/असमर्थता पेंशन प्राप्त है। औपबंधिक/पारिवारिक/ असाधारण पेंशन पार वाले को भी आदेय महँगाई राहत का भुगतान अनुमान्य होगा।
