MEMORANDUM

Subject: Revision of Pension of Retired Judicial Officers of the Tripura Judicial Service in compliance to the order of Hon'ble Supreme Court of India dated 19.05.2023 in All India Judges Association Vs Union of India.

In supersession of Finance Department, Government of Tripura Notification No. F.6(2)- FIN (PC)/97 dated 24.12.2010 as amended from time to time, the Governor is pleased to order that :-

- 1. The retirement benefit to the judicial officers, who retire/retired on or after 01.01.2016 shall be allowed as under:
- a) The pension and family pension shall be @ 50% and 30% respectively of the last pay drawn at the time of retirement.
- b) Qualifying service for earning full pension shall be 20 years.
- c) Last pay drawn shall continue to be taken as emoluments for purpose of calculation of pension.
- d) Commutation of pension shall be 50% of the pension with restoration after 15 years.
- e) The payment of DCRG and retirement Gratuity is revised to Rs.20 lakhs w.e.f. 01.01.2016 as per Rule 50(1)(a) of Central Civil Services (Pension) Rules, 1972. The maximum limit for retirement gratuity/death gratuity shall be increased by 25% whenever DA rises by 50%.
- f) The officers who have retired after 01.01.2016 and paid retirement gratuity as per existing provision and the maximum limit at the time, the differential gratuity payable on account of revision of pay shall be paid subject to revised maximum limit, i.e., Rs. 20 lakhs.

The aforesaid provisions will come into force w.e.f. 01.01.2016 and will be applicable to judicial officers who have retired or ceased to be in service due to death or retirement on or after 01.01.2016.

- 2. The pension/family pension of the Judicial Officers, who retired/died prior to 01.01.2016 shall be revised as under:
- (a) The revised pension/family pension of the judicial officers who have retired or died while in service prior to 01.01.2016 shall be as under:
 - (i) The existing pension/family pension shall be revised by the multiplier factor of 2.81

Or

Retired/Judicial Officers who expired to be placed notionally at the corresponding stage of the fitment table (indicated in item (iii)) in new proposed

pay on the basis of last pay drawn at the time of retirement, and the revised pension and family pension shall be @50% and 30% respectively of the new proposed pay as per fitment table, whichever is higher

(ii) The benefits of numbers of years of practice at bar subject to maximum of weightage of ten years will be given to direct recruits of Grade-Lof-the Tripura ludical Service, who retired prior to 01.01 2016.

- (b) The atoresaid provisions will come into force w.e.t. 01.01.2016 and will be applicable to judicial officers who have retired or ceased to be in service due to death or retirement prior to 01.01.2016.
- 3. The Additional quantum of pension/tamily pension shall be admissible to the Judicial Officers on completion of age of and at the revised rates specified below w.e.f. 01.01.2016.

Age of Pensioner/Family Pensioner	Additional quantum of pension	
From 75 years to less than 80 years	20% of revised basic pension/family pension	
From 80 years to less than 85 years	30% of revised basic pension/family pension	
From 85 years to less than 90 years	40% of revised basic pension/family pension	
From 90 years to less than 95 years	60% of revised basic pension/family pension	
From 95 years to less than 100 years	80% of revised basic pension/family pension	
100 years and above	100% of revised basic pension/family pension	

- 4. (i) Family Pension shall be paid to eligible family member(s) @ 30% as per Rule 54 of the Central Civil Services (Pension) Rules, 1972 at par with the spouse, after the death of the spouse.
- (ii) The quantum of family pension shall be worked out in the same manner as quantum of pension is worked out.
- (iii) Income limit, in relation to dependent family members (other than the spouse) for being eligible to get family pension shall be not less than Rs. 30,000/- per month (rupees thirty thousand per month).
- Arrears of pension/family pension to be paid after adjusting payment of interim relief already paid @ 30% of basic pension/family pension under Finance Department, Government of Tripura Memo No. F.6(1)-FIN(PC)/2018/65, dated 24.05.2018.
- 6. Payment as per revised rate of pension/family pension shall be made w.e.t. 01.07.2023 and arrear of pension/family pension for the period from 01.01.2016 to 30.06.2023 shall be made 25% by 31.08.2023, another 25% by 31.10.2023 and remaining 50% by 31.12.2023.
- 7. Financial Assistance in case of Death:
 - (i) The benefit of Family Pension as per Rule 54(3) of the CCS (Pension) Rules, as amended vide notification dated 19.09.2019 shall be extended to the family members

- (ii) The other benefits such as one time lump sum grant, compassionate appointment, permission to stay in official quarters etc. already in force in the State shall continue to apply, in addition to death gratuity.
- 8. This is issued with the concurrence of the Finance Department, Government of Tripura vide their U.O.No. 298 FIN(Estt-II)/23, dated 28.07.2023 and also approval of the Council of Ministers vide Memo.No.F.1(4)-GA(CAB)/2007, dated 09.08.2023.
