Subject : Amendment of Rule 3 & 7 of Tripura State Civil Services (Revised Pension) Rules 2009.

Sir,

I am to enclose herewith copy of the Notification No. F. 8(1)-FIN(G)/2014 dated 31-3-2014 and No. F. 8(1)-FIN(G)/2015 dated 25-6-2015 under which Government of Tripura has extended following benefits to their Pensioners/Family Pensioners by amending Rule-3 and 7 respectively of TSCS (RP) Rules 2009.

Sl. No.	Government Notification and Date	Nature of benefits
1.	F. 8(1)-FIN(G)/2014 Dated 31-3-2014	(i) Revised minimum Pension/Family Pension shall be ₹3120/- p.m. (ii) Maximum limit of modified revised pension shall be ₹38500/- and Family Pension shall be ₹19250/-. In both the cases financial benefits will be admissible from 01-04-2015.
2.	F. 8(1)-FIN(G)/2015 Dated 25-6-2015	(i) Basic pension plus 86% D.R. over basic pension plus 40% booster over basic pension in respect of those who retired from 01-01-1996 to 31-12-2005. (ii) Additional quantum of Pension/Family Pension to the Old Pensioners/Family Pensioner's, who have crossed/will cross 80 years of age. This benefit for eligible cases will be effective from 01-01-2009.

In view of the above, you are requested to arrange to circulate the aforesaid Notifications to all Pension Disbursing Authorities including Public Sector Banks under your jurisdiction for doing the needful at their end as per instructions contained in the Notifications ibid.

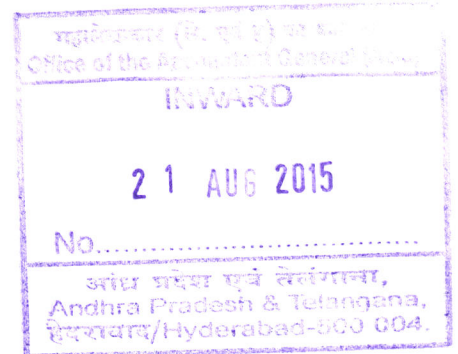

**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tripura is pleased to make the following Rules to further amend the Tripura State Civil Services (Revised Pension) Rules, 2009 (hereinafter referred to as the 'Principal Rules') namely :

**1] Short title and commencement :**

- i) These Rules may be called the 'Tripura State Civil Services (Revised Pension) (Fourth Amendment) Rules, 2015';
- ii) They shall be deemed to have come into force on and from the 1<sup>st</sup> day of January, 2006.

**2] Amendment of Rule 7 of the Principal Rules :**

2.1] The provision of sub-rule (i) of Rule 7 of the Principal Rules read with the 'Tripura State Civil Services (Revised Pension) (Second Amendment) Rules, 2012' shall be substituted with the following :

**“(i) Those who retired from 01-01-1996 to 31-12-2005 :**

Basic Pension (without merger) + 86% DR over basic pension (without merger) + 40% booster over basic pension (without merger). The total amount shall be rounded up to next multiple of 10.”

2.2] The provision of sub-rule (iv) of Rule 7 of the Principal Rules read with the 'Tripura State Civil Services (Revised Pension) (Second Amendment) Rules, 2012' shall be substituted with the following :

**“(iv) Pension/family pension available to the Pensioners/ Family Pensioners who have crossed/ will cross 80 years of age :**

<b>Age of Pensioner/ Family Pensioner</b>	<b>Additional quantum of pension</b>
From 80 years to less than 85 years	20% of revised basic pension/ family pension
From 85 years to less than 90 years	30% of revised basic pension/ family pension
From 90 years to less than 95 years	40% of revised basic pension/ family pension
From 95 years to less than 100 years	50% of revised basic pension/ family pension
From 100 years or more	100% of revised basic pension/ family pension

The quantum of pension/ family pension available to the old Pensioners/ Family Pensioners, who have crossed/ will cross 80 years of age, shall be increased at the rates mentioned above. This benefit for eligible cases (those who had already crossed 80 years of age up to 31-12-2008) will be effective from 01-01-2009. In respect of cases, where the pensioner will attain 80 years of age on or after 01-01-2009, the date of effect will be the 1<sup>st</sup> day of the month next to the month of attaining the age of 80 years. The amount of additional pension will be shown distinctly in the pension payment order."

2.3] The modified revised rate of pension mentioned in sub-rule (i) and sub-rule (iv) of Rule 7 of the Principal Rules above shall be computed notionally from 01-01-2006 or, as the case may be, from the date of superannuation/ retirement whichever is later. But financial benefit to be accrued on computation of modified revised pension will be admissible from 01-04-2015 or from the date of superannuation/ retirement, whichever is later."



## **NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tripura is pleased to make the following Rules to further amend the Tripura State Civil Services (Revised Pension) Rules, 2009 (hereinafter referred to as the 'Principal Rules'), namely :

**1) Short title and commencement :**

- i) These Rules may be called the 'Tripura State Civil Services (Revised Pension) (Third Amendment) Rules, 2015';
- ii) They shall be deemed to have come into force on and from the 1<sup>st</sup> day of January, 2006.

**2) Amendment of Rule 3 of the Principal Rules:**

**2.1]** Under sub-rule (1) and of Rule 3 read with the Tripura State Civil Services (Revised Pension) (Second Amendment) Rules, 2012, a new clause '(a)' shall be inserted as follows :

"(a) Under the modified revised pension, minimum pension/ family pension shall be Rs.3120/- per month (50% of sum of minimum of the pay in the Pay Band (Rs.4840/-) and Grade Pay of Rs.1400/-)".

**2.2]** Under sub-rule (2) and of Rule 3 read with the Tripura State Civil Services (Revised Pension) (First Amendment) Rules, 2009, a new clause '(a)' shall be inserted as follows :

"(a) The maximum limit of modified revised pension shall be 50% of the maximum of the modified revised Apex scale (Rs.77,000/-) i.e. Rs.38,500/- and the maximum limit of modified revised family pension shall be 50% of the maximum limit of pension i.e. Rs.19,250/-"

**2.3]** Under sub-rule (3) of Rule 3, a new clause '(a)' shall be inserted as follows:

"(a) The modified revised rate of pension within the limits of minimum and maximum pension mentioned in clause (a) of sub-rule (1) and clause (a) of sub-rule (2) of Rule 3 above shall be computed notionally from 01-01-2006 or, as the case may be, from the date of superannuation/ retirement whichever is later. But financial benefit to be accrued on computation of modified revised pension will be admissible from 01-04-2015 or from the date of superannuation/ retirement whichever is later."


