## MEMORANDUM

SEP 2014 Subject: Release of further instalment of Dearness Relief.

The undersigned is directed to refer to this Department's Memorandum of even number dated 31 December 2013 on the subject captioned above and to state that the Governor of Tripura is pleased to decide grant of further instalment of Dearness Relief @ 7% over the revised pension with effect from 01 July 2014 to the State Government Pensioners and Family Pensioners. With this release of instalment, total quantum of Dearness Relief payable to the State Government Pensioners and Family Pensioners with effect from 01-07-2014 shall stand at 64% (57% + 7%) over the revised pension.

- 2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 3. The Pension Disbursing Authorities including Public Sector Banks handling disbursement of pension/family pension to the State Government Pensioners and Family Pensioners are authorized to calculate and disburse Dearness Relief at the above rate and manner from **01-07-2014**.
- 4. The expenditure on payment of Dearness Relief on pension/family pension to the State Government Pensioners and Family Pensioners is debitable to the Major Head '2071-Pension and other Retirement Benefits'.
