In continuation to this office circular No. Pen.Co-ordn./51/Vol-VI/204/Vol-II/156 dated 1/2/2016, it is stated that the Govt. of West Bengal in their Higher Education, Science and Technology & Biotechnology Department, C.S. Branch in their order no. 104-Edn(CS)/1P-1/2013, dated 7/2/2017 have sanctioned dearness relief to the pensioners/family pensioners of the **teaching and non-teaching staff** of the State-Aided **Non-Government. Colleges** in this State @ 85% with effect from 1/1/2017.
