MEMORANDUM

Subject: - Release of further installment of Dearness Relief @ 5% with effect from 1st July, 2012 over the revised pension to the State Government pensioners/family pensioners.

The undersigned is directed to refer to this Department's Memorandum No.F.8(3)-FIN(G)/2011 dated 1st Feb, 2012 on the above noted subject and to state that the Governor, Tripura is pleased to decide grant of further installment of Dearness Relief @ 5% over the revised pension with effect from 1st July, 2012 to the State Government Pensioners and Family Pensioners. With this release of installment, total quantum of Dearness Relief payable to the State Government Pensioners & Family Pensioners with effect from 01-07-2012 shall stand as 35% (30% + 5%) over the revised pension.

- 2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 3. The pension disbursing authorities including Public Sector Banks handling disbursement of pension/family pension to the State Government pensioners and family pensioners are authorized to calculate and disburse Dearness Relief at the above rates and manner from **01-07-2012**.
- 4. The expenditure on payment of Dearness Relief on Pension/Family pension to State Government pensioners and Family Pensioners is debit-able to the Major Head 2071-Pension and other Retirement Benefits'
