

MEMORANDUM

Subject: - Release of further installment of Dearness Relief.

The undersigned is directed to refer to this Department's Memorandum of even number dated 17<sup>th</sup> July, 2013 on the subject captioned above and to state that the Governor of Tripura is pleased to decide grant of further installment of Dearness Relief @ 10% over the revised pension with effect from 1<sup>st</sup> January, 2014 to the State Government Pensioners and Family Pensioners. With this release of installment, total quantum of Dearness Relief payable to the State Government Pensioners & Family Pensioners with effect from 01-01-2014 shall stand as 57% (47% + 10%) over the revised pension.

2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
3. The pension disbursing authorities including Public Sector Banks handling disbursement of pension/family pension to the State Government pensioners and family pensioners are authorized to calculate and disburse Dearness Relief at the above rate and manner from 01-01-2014.
4. The expenditure on payment of Dearness Relief on Pension/Family pension to the State Government Pensioners and Family Pensioners is debit able to the Major Head '2071-Pension and other Retirement Benefits'


