Rs.700/- (Rupees Seven hundred) only per head.
2.	DRWs/ MRWs/ PTW/ Fixed Pay Employee and other similar workers engaged with prior concurrence of the Finance Department.	
3.	DRWs/ MRWs/ Home Guard/ PTW/ Fixed Pay Employee and other similar workers engaged prior to 01/04/2004 without concurrence of the Finance Department.
