N O T I F I C A T I O N

In exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India the Governor is pleased to make the following Rules, further to amend Tripura State Civil Service (Revised Pension) Rules, 2009, namely :-

1. Short title and commencement

- i) These Rules may be called the Tripura State Civil Services (Revised Pension) (Second Amendment) Rules, 2012.
- ii) They shall be deemed to have come into force on and from the 1st day of January, 2006.

2. Provision under Sub-rule (1) of Rule 3 shall be substituted with the following:-

"Minimum Pension/family pension shall be Rs.3020/ per month (50% of minimum of revised pay band Rs.4840/- plus Grade Pay Rs.1200/-)"

3. Amendment of Rule 7 of the Tripura State Civil Services (Revised Pension) Rules, 2009.

- (i) The provision of Sub-rule(i) of Rule 7 of the Tripura State Civil Services(Revised Pension) Rules, 2009 shall be substituted under the existing heading with the following:-

"Basic Pension (without merger) + 86% DR over basic pension (without merger) + 35% booster over basic pension (without merger). The total rounded off to next multiple of 10 and it shall be re-fixed notionally w.e.f. 01/01/2006 to 30/11/2012. Financial benefit on the re-fixation of pension on the 86% will be provided w.e.f. 01/12/2012".

- (ii) The provision of Sub-rule(ii) of Rule 7 of the Tripura State Civil Services(Revised Pension) Rules, 2009 shall be substituted under the existing heading with the following:-

"Basic Pension (without merger) + 86% DR over basic pension (without merger) + 40% booster over basic pension (without merger). The total rounded off to next multiple of 10 and it shall be re-fixed notionally w.e.f. 01/01/2006 to 30/11/2012. Financial benefit on the re-fixation of pension on the 86% will be provided w.e.f. 01/12/2012".

(Page-2)

(iii) The provision of Sub-rule(iii) of Rule 7 of the Tripura State Civil Services(Revised Pension) Rules, 2009 shall be substituted under the existing heading with the following:-

"Basic Pension (without merger) + 86% DR over basic pension (without merger) + 45% booster over basic pension (without merger). The total rounded off to next multiple of 10 and it shall be re-fixed notionally w.e.f. 01/01/2006 to 30/11/2012. Financial benefit on the re-fixation of pension on the 86% will be provided w.e.f. 01/12/2012".
