All Heads of Departments/Heads of Offices Concerned are, therefore, requested to arrange payment of DA as per the above enhanced rates of DA i.e from 148% to 154% w.e.f. 01-01-2019 to the employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/grade pay as per 6th Central Pay Commission.

This enhanced rate of DA is applicable as DA/DR on their prerevised Pay/Pension from the same date and on the same terms and conditions in respect of serving members of Tripura Judicial Service and those retired from Tripura Judicial Service also.
